1.8	Subd. 3. <b>Use of revenues.</b> Revenues received from taxes authorized by subdivisions 1
1.9	and 2 must be used by the city to pay the cost of collecting the taxes and to pay for the
1.10	following projects:
1.11	(1) \$4,500,000 for construction and completion of park improvement projects, including
1.12	St. Louis River riverfront improvements; Veteran's Park construction and improvements;
1.13	improvements to the Hilltop Park soccer complex and Braun Park baseball complex; capital
1.14	equipment and building and grounds improvements at the Pine Valley Park/Pine Valley
1.15	Hockey Arena/Cloquet Area Recreation Center; and development of pedestrian trails within

2.1	Authorized expenses include, but are not limited to, acquiring property and paying
2.2	construction expenses related to these improvements, and paying debt service on bonds or
2.3	other obligations issued to finance acquisition and construction of these improvements.
2.4	Notwithstanding the revenue allocations in clauses (1) and (3), if the amount spent for the
2.5	improvements under clause (2) are less than the \$5,800,000 allowed under that clause, the
2.6	total amount spent for the purposes listed in clauses (1) and (3) may be increased by the
