1.1 A bill for an act  
1.2 relating to capital investment; appropriating money for capital improvements to  
1.3 the Chisholm Sports Arena and Curling Club; amending an appropriation for the  
1.4 Chisholm Sports Arena and Curling Club; authorizing the sale and issuance of  
1.5 state bonds; amending Laws 2023, chapter 71, article 1, section 14, subdivision  
1.6 12.

1.7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.8 Section 1. Laws 2023, chapter 71, article 1, section 14, subdivision 12, is amended to  
1.9 read:

1.10 Subd. 12. **Chisholm; Ice Arena and Curling**  
1.11 **Club** 3,000,000

1.12 For a grant to the city of Chisholm to  
1.13 ~~pre-design~~, design, and construct capital  
1.14 improvements to the existing Sports Arena  
1.15 and Curling Club, located in Chisholm,  
1.16 including replacing an existing ice plant  
1.17 serving both the hockey arena and the curling  
1.18 club, adding new heating mains and replacing  
1.19 curling mains, and replacing the floor systems  
1.20 in both the hockey arena and the curling club;  
1.21 ~~and installing dehumidification systems in~~  
1.22 ~~both the hockey arena and the curling club.~~

2.1        **Sec. 2. CHISHOLM; ICE ARENA AND CURLING CLUB.**

2.2            **Subdivision 1. Appropriation.** \$1,000,000 is appropriated from the bond proceeds fund  
2.3 to the commissioner of employment and economic development for a grant to the city of  
2.4 Chisholm to design and construct capital improvements to the existing Sports Arena and  
2.5 Curling Club, located in Chisholm, including replacing an existing ice plant serving both  
2.6 the hockey arena and the curling club, adding new heating mains and replacing curling  
2.7 mains, and replacing the floor systems in both the hockey arena and the curling club. This  
2.8 appropriation is in addition to the appropriation in Laws 2023, chapter 71, article 1, section  
2.9 14, subdivision 12, and is for the same purposes.

2.10           **Subd. 2. Bond sale.** To provide the money appropriated in this section from the bond  
2.11 proceeds fund, the commissioner of management and budget shall sell and issue bonds of  
2.12 the state in an amount up to \$1,000,000 in the manner, upon the terms, and with the effect  
2.13 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota  
2.14 Constitution, article XI, sections 4 to 7.

2.15           **EFFECTIVE DATE.** This section is effective the day following final enactment.
