BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **STILLWATER; MYRTLE STREET RECONSTRUCTION.**
- 1.6

Subdivision 1. **Appropriation.** \$1,927,000 is appropriated from the bond proceeds fund
- 1.7

to the commissioner of transportation for a grant to the city of Stillwater to design and
- 1.8

reconstruct Myrtle Street from Owens Street to Main Street. This appropriation includes

money for the replacement of sidewalk, curb, gutter, and associated public infrastructure.

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
- 1.11

proceeds fund, the commissioner of management and budget shall sell and issue bonds of
- 1.12

the state in an amount up to \$1,927,000 in the manner, upon the terms, and with the effect
- 1.13

prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
- 1.14

Constitution, article XI, sections 4 to 7.
