1.6	Subd. 2. Dental reimbursement. (a) Effective for services rendered on or after
1.7	October 1, 1992 January 1, 2014, the commissioner shall make payments for dental
1.8	services as follows:
1.9	(1) dental services shall be paid at the lower of:
1.10	(i) (1) submitted charges; or
1.11	(ii) 25 percent above the rate in effect on June 30, 1992; and
1.12	(2) dental rates shall be converted from the 50th percentile of 1982 to the 50th
1.13	percentile of 1989, less the percent in aggregate necessary to equal the above increases 75
1.14	percent of the statewide median rate for all charges in effect during calendar year 2011.
1.15	(b) Beginning October 1, 1999, the payment for tooth sealants and fluoride treatments
1.16	shall be the lower of (1) submitted charge, or (2) 80 percent of median 1997 charges.
1.17	(c) Effective for services rendered on or after January 1, 2000, payment rates for
1.18	dental services shall be increased by three percent over the rates in effect on December

2.1	(f) Effective for dental services rendered on or after October 1, 2010, by a
2.2	state-operated dental elinic, payment shall be paid on a reasonable cost basis that is based
2.3	on the Medicare principles of reimbursement. This payment shall be effective for services
