1.7	Section 1. Minnesota Statutes 2023 Supplement, section 239.791, subdivision 8, is amended
1.8	to read:
1.9	Subd. 8. Disclosure; reporting. (a) A refinery or terminal, shall provide, at the time
1.10	gasoline is sold or transferred from the refinery or terminal, a bill of lading or shipping
1.11	manifest to the person who receives the gasoline. For oxygenated gasoline, the bill of lading
1.12	or shipping manifest must include the identity and the volume percentage or gallons of
1.13	oxygenate included in the gasoline, and it must state: "This fuel contains an oxygenate. Do
1.14	not blend this fuel with ethanol or with any other oxygenate." For nonoxygenated gasoline,
1.15	the bill or manifest must state: "This fuel is not oxygenated. It must not be sold at retail in
1.16	Minnesota." This subdivision does not apply to sales or transfers of gasoline between
1.17	refineries, between terminals, or between a refinery and a terminal.
1.18	(b) A delivery ticket required under section 239.092 for biofuel blended with gasoline

239.791 OXYGENATED GASOLINE.

Subd. 3. **Blending restriction.** When gasoline contains an oxygenate, a person responsible for the product shall not blend the product with ethanol or with any other oxygenate after it is transferred or otherwise removed from a refinery or terminal.
