proof of identity; or any other official documentation the commissioner considers necessary
to determine eligibility.

(d) The commissioner may deny eligibility or terminate benefits under this section to 2.24 any person who has not provided sufficient documentation to determine eligibility for the 2.25 program. An applicant may appeal the commissioner's eligibility determination or termination 2.26 of benefits in writing to the commissioner at any time.
