1.7	Section 1. [473.4486] MUNICIPAL APPROVAL OF GUIDEWAY PLANS.
1.8	Subdivision 1. Application. "Guideway" has the meaning given in section 473.4485,
1.9	subdivision 1, paragraph (d), except that this section does not apply to light rail transit.
1.10	Subd. 2. Preliminary design plans; public hearing. Before final design plans are
1.11	prepared for a guideway in the metropolitan area, the council must hold a public hearing
1.12	on the physical design component of the preliminary design plans. The council must provide
1.13	appropriate public notice of the hearing and publicity to ensure that affected parties have
1.14	an opportunity to present their views at the hearing. The council must summarize the
1.15	proceedings and testimony and maintain the record of a hearing held under this section,
1.16	including any written statements submitted.
1.17	Subd. 3. Preliminary design plans; local approval. At least 30 days before the hearing
