1.22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.23 ARTICLE 1

1.24 TRANSFER CARE SPECIALISTS

1.25 Section 1. Minnesota Statutes 2022, section 149A.01, subdivision 3, is amended to read:

1.26 Subd. 3. **Exceptions to licensure.** (a) Except as otherwise provided in this chapter,

1.27 nothing in this chapter shall in any way interfere with the duties of:

1.28 (1) an anatomical bequest program located within an accredited school of medicine or

1.29 an accredited college of mortuary science;

(2) a person engaged in the performance of duties prescribed by law relating to the conditions under which unclaimed dead human bodies are held subject to anatomical study;

(3) authorized personnel from a licensed ambulance service in the performance of their duties;

(4) licensed medical personnel in the performance of their duties; or

(5) the coroner or medical examiner in the performance of the duties of their offices.

(b) This chapter does not apply to or interfere with the recognized customs or rites of any culture or recognized religion in the ceremonial washing, dressing, casketing, and public transportation of their dead, to the extent that all other provisions of this chapter are complied with.

(c) Noncompensated persons with the right to control the dead human body, under section 149A.80, subdivision 2, may remove a body from the place of death; transport the body; prepare the body for disposition, except embalming; or arrange for final disposition of the body, provided that all actions are in compliance with this chapter.

(d) Persons serving internships pursuant to section 149A.20, subdivision 6, ~~or~~; students officially registered for a practicum or clinical through a program of mortuary science accredited by the American Board of Funeral Service Education; or transfer care specialists registered pursuant to section 149A.47 are not required to be licensed, provided that the ~~persons or~~ students, or transfer care specialists are registered with the commissioner and act under the direct and exclusive supervision of a person holding a current license to practice mortuary science in Minnesota.

(e) Notwithstanding this subdivision, nothing in this section shall be construed to prohibit an institution or entity from establishing, implementing, or enforcing a policy that permits only persons licensed by the commissioner to remove or cause to be removed a dead body or body part from the institution or entity.

(f) An unlicensed person may arrange for and direct or supervise a memorial service if that person or that person's employer does not have charge of the dead human body. An unlicensed person may not take charge of the dead human body, unless that person has the right to control the dead human body under section 149A.80, subdivision 2, or is that person's noncompensated designee.

3.2 Subd. 13a. **Direct supervision.** "Direct supervision" means overseeing the performance
3.3 of an individual. For the purpose of a clinical, practicum, or internship, direct supervision
3.4 means that the supervisor is available to observe and correct, as needed, the performance
3.5 of the trainee. For the purpose of a transfer care specialist, direct supervision means that
3.6 the supervisor is available by being physically present or by telephone to advise and correct,
3.7 as needed, the performance of the transfer care specialist. The supervising mortician
3.8 ~~supervisor~~ is accountable for the actions of the clinical student, practicum student, or intern
3.9 throughout the course of the training. The supervising mortician is accountable for any
3.10 violations of law or rule, in the performance of their duties, by the clinical student, practicum
3.11 student, ~~or intern,~~ or transfer care specialist.

3.17 supervision of a licensed mortician.

3.19 **149A.03 DUTIES OF COMMISSIONER.**

3.20 The commissioner shall:

3.21 (1) enforce all laws and adopt and enforce rules relating to the:

3.22 (i) removal, preparation, transportation, arrangements for disposition, and final disposition
3.23 of dead human bodies;

3.24 (ii) licensure, registration, and professional conduct of funeral directors, morticians,
3.25 interns, practicum students, ~~and~~ clinical students, and transfer care specialists;

3.26 (iii) licensing and operation of a funeral establishment;

3.27 (iv) licensing and operation of an alkaline hydrolysis facility; and

3.28 (v) licensing and operation of a crematory;

3.29 (2) provide copies of the requirements for licensure, registration, and permits to all

4.2 persons and other legal entities;

4.11 science licensing and the removal, preparation, transportation, arrangements for disposition,
4.12 and final disposition of dead human bodies to enable consumers to file complaints against
4.13 licensees and others who may have violated those laws or rules;

4.14 (10) evaluate the laws, rules, and procedures regulating the practice of mortuary science
4.15 in order to refine the standards for licensing and to improve the regulatory and enforcement
4.16 methods used; and

4.17 (11) initiate proceedings to address and remedy deficiencies and inconsistencies in the
4.18 laws, rules, or procedures governing the practice of mortuary science and the removal,
4.19 preparation, transportation, arrangements for disposition, and final disposition of dead
4.20 human bodies.

4.22 **149A.09 DENIAL; REFUSAL TO REISSUE; REVOCATION; SUSPENSION;**
4.23 **LIMITATION OF LICENSE, REGISTRATION, OR PERMIT.**

4.24 Subdivision 1. **Denial; refusal to renew; revocation; and suspension.** The regulatory
4.25 agency may deny, refuse to renew, revoke, or suspend any license, registration, or permit
4.26 applied for or issued pursuant to this chapter when the person subject to regulation under
4.27 this chapter:

4.28 (1) does not meet or fails to maintain the minimum qualification for holding a license,
4.29 registration, or permit under this chapter;

(2) submits false or misleading material information to the regulatory agency in connection with a license, registration, or permit issued by the regulatory agency or the application for a license, registration, or permit;

(3) violates any law, rule, order, stipulation agreement, settlement, compliance agreement, license, registration, or permit that regulates the removal, preparation, transportation, arrangements for disposition, or final disposition of dead human bodies in Minnesota or any other state in the United States;

(4) is convicted of a crime, including a finding or verdict of guilt, an admission of guilt, or a no contest plea in any court in Minnesota or any other jurisdiction in the United States. "Conviction," as used in this subdivision, includes a conviction for an offense which, if committed in this state, would be deemed a felony or gross misdemeanor without regard to its designation elsewhere, or a criminal proceeding where a finding or verdict of guilty is made or returned, but the adjudication of guilt is either withheld or not entered;

(5) is convicted of a crime, including a finding or verdict of guilt, an admission of guilt, or a no contest plea in any court in Minnesota or any other jurisdiction in the United States that the regulatory agency determines is reasonably related to the removal, preparation, transportation, arrangements for disposition or final disposition of dead human bodies, or the practice of mortuary science;

(6) is adjudicated as mentally incompetent, mentally ill, developmentally disabled, or mentally ill and dangerous to the public;

(7) has a conservator or guardian appointed;

(8) fails to comply with an order issued by the regulatory agency or fails to pay an administrative penalty imposed by the regulatory agency;

(9) owes uncontested delinquent taxes in the amount of \$500 or more to the Minnesota Department of Revenue, or any other governmental agency authorized to collect taxes anywhere in the United States;

(10) is in arrears on any court ordered family or child support obligations; or

(11) engages in any conduct that, in the determination of the regulatory agency, is unprofessional as prescribed in section 149A.70, subdivision 7, or renders the person unfit to practice mortuary science or to operate a funeral establishment or crematory.

Subd. 2. **Hearings related to refusal to renew, suspension, or revocation of license, registration, or permit.** If the regulatory agency proposes to deny renewal, suspend, or revoke a license, registration, or permit issued under this chapter, the regulatory agency

must first notify, in writing, the person against whom the action is proposed to be taken and provide an opportunity to request a hearing under the contested case provisions of sections 14.57 to 14.62. If the subject of the proposed action does not request a hearing by notifying the regulatory agency, by mail, within 20 calendar days after the receipt of the notice of proposed action, the regulatory agency may proceed with the action without a hearing and the action will be the final order of the regulatory agency.

Subd. 3. **Review of final order.** A judicial review of the final order issued by the regulatory agency may be requested in the manner prescribed in sections 14.63 to 14.69. Failure to request a hearing pursuant to subdivision 2 shall constitute a waiver of the right to further agency or judicial review of the final order.

Subd. 4. **Limitations or qualifications placed on license, registration, or permit.** The regulatory agency may, where the facts support such action, place reasonable limitations or qualifications on the right to practice mortuary science ~~or~~, to operate a funeral establishment or crematory, or to perform activities or actions permitted under this chapter.

Subd. 5. **Restoring license, registration, or permit.** The regulatory agency may, where there is sufficient reason, restore a license, registration, or permit that has been revoked, reduce a period of suspension, or remove limitations or qualifications.

Sec. 6. Minnesota Statutes 2022, section 149A.11, is amended to read:

149A.11 PUBLICATION OF DISCIPLINARY ACTIONS.

The regulatory agencies shall report all disciplinary measures or actions taken to the commissioner. At least annually, the commissioner shall publish and make available to the public a description of all disciplinary measures or actions taken by the regulatory agencies. The publication shall include, for each disciplinary measure or action taken, the name and business address of the licensee ~~or~~, intern, or transfer care specialist; the nature of the misconduct; and the measure or action taken by the regulatory agency.

Sec. 7. [149A.47] TRANSFER CARE SPECIALIST.

Subdivision 1. **General.** A transfer care specialist may remove a dead human body from the place of death under the direct supervision of a licensed mortician if the transfer care specialist is registered with the commissioner in accordance with this section. A transfer care specialist is not licensed to engage in the practice of mortuary science and shall not engage in the practice of mortuary science except as provided in this section. A transfer care specialist must be an employee of a licensed funeral establishment.

7.1 Subd. 2. **Registration.** (a) To be eligible for registration as a transfer care specialist, an
7.2 applicant must submit to the commissioner:

7.3 (1) a completed application on a form provided by the commissioner that includes at a
7.4 minimum:

7.5 (i) the applicant's name, home address and telephone number, business name, business
7.6 address and telephone number, and email address; and

7.7 (ii) the name, license number, business name, and business address and telephone number
7.8 of the supervising licensed mortician;

7.9 (2) proof of completion of a training program that meets the requirements specified in
7.10 subdivision 4; and

7.11 (3) the appropriate fee specified in section 149A.65.

7.12 (b) All transfer care specialist registrations are valid for one calendar year, beginning
7.13 on January 1 and ending on December 31 regardless of the date of issuance. Fees shall not
7.14 be prorated.

7.15 Subd. 3. **Duties.** (a) A transfer care specialist registered under this section is authorized
7.16 to perform the removal of a dead human body from the place of death in accordance with
7.17 this chapter to a licensed funeral establishment. A transfer care specialist must comply with
7.18 the universal precaution requirements in section 149A.91, subdivision 1, when handling a
7.19 dead human body.

7.20 (b) A transfer care specialist must work under the direct supervision of a licensed
7.21 mortician. The supervising mortician is responsible for the work performed by the transfer
7.22 care specialist. A licensed mortician may supervise up to four transfer care specialists at
7.23 any one time.

7.24 Subd. 4. **Training program and continuing education.** (a) Each transfer care specialist
7.25 must complete a training program prior to initial registration. A training program must be
7.26 at least seven hours long and must cover, at a minimum, the following:

7.27 (1) ethical care and transportation procedures for a deceased person;

7.28 (2) health and safety concerns to the public and the individual performing the transfer
7.29 of the deceased person and the use of universal precautions and other reasonable precautions
7.30 to minimize the risk for transmitting communicable diseases; and

7.31 (3) all relevant state and federal laws and regulations related to the transfer and
7.32 transportation of deceased persons.

(b) A transfer care specialist must complete three hours of continuing education annually on content described in paragraph (a), clauses (1) to (3), and submit evidence of completion with the individual's registration renewal.

Subd. 5. **Renewal.** (a) A registration issued under this section expires on December 31 of the calendar year in which the registration was issued and must be renewed to remain valid.

(b) To renew a registration, a transfer care specialist must submit to the commissioner a completed renewal application as provided by the commissioner. The renewal application must include proof of completion of the continuing education requirements in subdivision 4.

Sec. 8. Minnesota Statutes 2022, section 149A.60, is amended to read:

149A.60 PROHIBITED CONDUCT.

The regulatory agency may impose disciplinary measures or take disciplinary action against a person whose conduct is subject to regulation under this chapter for failure to comply with any provision of this chapter or laws, rules, orders, stipulation agreements, settlements, compliance agreements, licenses, registrations, and permits adopted, or issued for the regulation of the removal, preparation, transportation, arrangements for disposition or final disposition of dead human bodies, or for the regulation of the practice of mortuary science.

Sec. 9. Minnesota Statutes 2022, section 149A.61, subdivision 4, is amended to read:

Subd. 4. **Licensees ~~and~~, interns, and transfer care specialists.** A licensee ~~or~~ intern, or transfer care specialist regulated under this chapter may report to the commissioner any conduct that the licensee ~~or~~ intern, or transfer care specialist has personal knowledge of, and reasonably believes constitutes grounds for, disciplinary action under this chapter.

Sec. 10. Minnesota Statutes 2022, section 149A.61, subdivision 5, is amended to read:

Subd. 5. **Courts.** The court administrator of district court or any court of competent jurisdiction shall report to the commissioner any judgment or other determination of the court that adjudges or includes a finding that a licensee ~~or~~ intern, or transfer care specialist is a person who is mentally ill, mentally incompetent, guilty of a felony or gross misdemeanor, guilty of violations of federal or state narcotics laws or controlled substances acts; appoints a guardian or conservator for the licensee ~~or~~ intern, or transfer care specialist; or commits a licensee ~~or~~ intern, or transfer care specialist.

12.22 specialist must retain a copy of the certificate of removal at the transfer care specialist's
12.23 business address as registered with the commissioner for a period of three calendar years
12.24 following the date of removal. Following this period, and subject to any other laws requiring
12.25 retention of records, the funeral establishment may then place the records in storage or
12.26 reduce them to microfilm, microfiche, laser disc, or any other method that can produce an
12.27 accurate reproduction of the original record, for retention for a period of ten calendar years
12.28 from the date of the removal of the body. At the end of this period and subject to any other
12.29 laws requiring retention of records, the funeral establishment may destroy the records by
12.30 shredding, incineration, or any other manner that protects the privacy of the individuals
12.31 identified in the records.

ARTICLE 2**BEHAVIOR ANALYST LICENSURE****Section 1. [148.9981] DEFINITIONS.**

Subdivision 1. Scope. For the purposes of sections 148.9981 to 148.9995, the terms in this section have the meanings given.

Subd. 2. Accredited school or educational program. "Accredited school or educational program" means a school, university, college, or other postsecondary education program that, at the time the student completes the program, is accredited by a regional accrediting association whose standards are substantially equivalent to those of the North Central Association of Colleges and Postsecondary Education Institutions or an accrediting association that evaluates schools of behavior analysis, psychology, or education for inclusion of the education, practicum, and core function standards.

Subd. 3. Advisory council. "Advisory council" means the Behavior Analyst Advisory Council established in section 148.9994.

Subd. 4. Board. "Board" means the Board of Psychology established in section 148.90.

Subd. 5. Certifying entity. "Certifying entity" means the Behavior Analyst Certification Board, Inc., or a successor organization or other organization approved by the board in consultation with the advisory council.

Subd. 6. Client. "Client" means an individual who is the recipient of behavior analysis services. Client also means "patient" as defined in section 144.291, subdivision 2, paragraph (g).

Subd. 7. Licensed behavior analyst. "Licensed behavior analyst" or "behavior analyst" means an individual who holds a valid license issued under sections 148.9981 to 148.9995 to engage in the practice of applied behavior analysis.

Subd. 8. Licensee. "Licensee" means an individual who holds a valid license issued under sections 148.9981 to 148.9995.

Subd. 9. Practice of applied behavior analysis. (a) "Practice of applied behavior analysis" means the design, implementation, and evaluation of social, instructional, and environmental modifications to produce socially significant improvements in human behavior. The practice of applied behavior analysis includes the empirical identification of functional relations between behavior and environmental factors, known as functional behavioral assessment and analysis. Applied behavior analysis interventions are based on scientific research, direct and indirect observation, and measurement of behavior and environment

14.1 and utilize contextual factors, motivating operations, antecedent stimuli, positive
14.2 reinforcement, and other procedures to help individuals develop new behaviors, increase
14.3 or decrease existing behaviors, and emit behaviors under specific social, instructional, and
14.4 environmental conditions.

14.5 (b) The practice of applied behavior analysis does not include the diagnosis of psychiatric
14.6 or mental health disorders, psychological testing, neuropsychology, psychotherapy, cognitive
14.7 therapy, sex therapy, hypnotherapy, psychoanalysis, or psychological counseling.

14.8 **EFFECTIVE DATE.** This section is effective July 1, 2024.

14.9 **Sec. 2. [148.9982] DUTIES OF THE BOARD OF PSYCHOLOGY.**

14.10 Subdivision 1. **General.** The board, in consultation with the advisory council, must:

14.11 (1) adopt and enforce standards for licensure, licensure renewal, and the regulation of
14.12 behavior analysts;

14.13 (2) issue licenses to qualified individuals under sections 148.9981 to 148.9995;

14.14 (3) carry out disciplinary actions against licensed behavior analysts;

14.15 (4) educate the public about the existence and content of the regulations for behavior

Subd. 5. **Late renewal fee.** If the application for license renewal is postmarked or received after the expiration date of the license or the following business day if the expiration date falls on a Saturday, Sunday, or holiday, the licensee must pay a biennial renewal late fee as specified by section 148.9995, in addition to the renewal fee, before the licensee's application for license renewal will be considered by the board.

Subd. 2. **Use of titles.** (a) An individual must not use a title incorporating the words "licensed behavior analyst," or "behavior analyst," or use any other title or description stating or implying that they are licensed or otherwise qualified to practice applied behavior analysis, unless that person holds a valid license under sections 148.9981 to 148.9995.

(b) Notwithstanding paragraph (a), a licensed psychologist who practices applied behavior analysis within the psychologist's scope of practice may use the title "behavior analyst," but

17.1 must not use the title "licensed behavior analyst" unless the licensed psychologist holds a
17.2 valid license as a behavior analyst issued under sections 148.9981 to 148.9995.

17.3 Subd. 3. **Penalty.** An individual who violates this section is guilty of a misdemeanor.

17.4 **EFFECTIVE DATE.** This section is effective July 1, 2024.

17.5 Sec. 7. **[148.9987] EXCEPTIONS TO LICENSE REQUIREMENT.**

17.6 (a) Sections 148.9981 to 148.9995 must not be construed to prohibit or restrict:

18.2 analyst student or intern.

18.3 (b) Notwithstanding paragraph (a), a licensed psychologist may supervise an unlicensed
18.4 supervisee, trainee, student, or intern who is engaged in the practice of behavior analysis if
18.5 the supervision is authorized under the Minnesota Psychology Practice Act.

18.6 **EFFECTIVE DATE.** This section is effective July 1, 2024.

18.7 Sec. 8. **[148.9988] NONTRANSFERABILITY OF LICENSES.**

18.8 A behavior analyst license is not transferable.

18.9 **EFFECTIVE DATE.** This section is effective July 1, 2024.

18.10 Sec. 9. **[148.9989] DUTY TO MAINTAIN CURRENT INFORMATION.**

18.11 All licensees and applicants for licensure must notify the board within 30 days of the
18.12 occurrence of:

18.13 (1) a change of name, address, place of employment, or home or business telephone
18.14 number; or

18.15 (2) a change in any other application information.

18.16 **EFFECTIVE DATE.** This section is effective July 1, 2024.

18.17 Sec. 10. **[148.999] DISCIPLINE; REPORTING.**

18.18 For purposes of sections 148.9981 to 148.9995, behavior analysts are subject to the
18.19 provisions of sections 148.941, 148.952 to 148.965, and 148.98.

18.20 **EFFECTIVE DATE.** This section is effective July 1, 2024.

18.21 Sec. 11. **[148.9991] COMPETENT PROVISION OF SERVICES.**

18.22 Subdivision 1. **Limits on practice.** Behavior analysts must limit practice to the client
18.23 populations and services for which the behavior analysts have competence or for which the
18.24 behavior analysts are developing competence.

18.25 Subd. 2. **Developing competence.** When a behavior analyst is developing competence
18.26 in a service, method, or procedure, or is developing competence to treat a specific client
18.27 population, the behavior analyst must obtain professional education, training, continuing
18.28 education, consultation, supervision or experience, or a combination thereof, necessary to
18.29 demonstrate competence.

19.1 Subd. 3. **Limitations.** A behavior analyst must recognize the limitations to the scope of
19.2 practice of applied behavior analysis. When the needs of a client appear to be outside the

19.15 (b) "Other person" means an immediate family member or someone who personally
19.16 knows the client and has reason to believe the client is capable of and will carry out a serious,

19.18 (c) "Reasonable efforts" means communicating a serious, specific threat to the potential
19.19 victim and, if unable to make contact with the potential victim, communicating the serious,
19.20 specific threat to the law enforcement agency closest to the potential victim or the client.

19.21 (d) "Licensee" has the meaning given in section 148.9981 and includes behavior analysis
19.22 students, interns, and unlicensed supervisees who are participating in a behavior analysis
19.23 practicum or enrolled in an accredited school or educational program.

19.24 Subd. 2. **Duty to warn.** The duty to predict, warn of, or take reasonable precautions to
19.25 provide protection from violent behavior arises only when a client or other person has
19.26 communicated to the licensee a specific, serious threat of physical violence against a specific,
19.27 clearly identified or identifiable potential victim. If a duty to warn arises, the duty is
19.28 discharged by the licensee if reasonable efforts are made to communicate the threat.

19.29 Subd. 3. **Liability standard.** If no duty to warn exists under subdivision 2, then no
19.30 monetary liability and no cause of action may arise against a licensee for failure to predict,
19.31 warn of, or take reasonable precautions to provide protection from a client's violent behavior.

20.1 Subd. 4. **Disclosure of confidences.** Good faith compliance with the duty to warn must
20.2 not constitute a breach of confidence and must not result in monetary liability or a cause of
20.3 action against the licensee.

20.4 Subd. 5. **Continuity of care.** Subdivision 2 must not be construed to authorize a licensee
20.5 to terminate treatment of a client as a direct result of a client's violent behavior or threat of
20.6 physical violence unless the client is referred to another practitioner or appropriate health
20.7 care facility.

20.8 Subd. 6. **Exception.** This section does not apply to a threat to commit suicide or other
20.9 threats by a client to harm the client, or to a threat by a client who is adjudicated as a person
20.10 who has a mental illness and is dangerous to the public under chapter 253B.

20.11 Subd. 7. **Optional disclosure.** This section must not be construed to prohibit a licensee
20.12 from disclosing confidences to third parties in a good faith effort to warn or take precautions
20.13 against a client's violent behavior or threat to commit suicide for which a duty to warn does
20.14 not arise.

20.15 Subd. 8. **Limitation on liability.** No monetary liability and no cause of action or
20.16 disciplinary action by the board may arise against a licensee for disclosure of confidences
20.17 to third parties, for failure to disclose confidences to third parties, or for erroneous disclosure
20.18 of confidences to third parties in a good faith effort to warn against or take precautions
20.19 against a client's violent behavior or threat of suicide for which a duty to warn does not
20.20 arise.

21.8 Subd. 3. **Emergency or crisis services.** Informed consent is not required when a behavior
21.9 analyst is providing emergency or crisis services. If services continue after the emergency
21.10 or crisis has abated, informed consent must be obtained.

21.11 **EFFECTIVE DATE.** This section is effective July 1, 2024.

21.12 Sec. 14. **[148.9994] BEHAVIOR ANALYST ADVISORY COUNCIL.**

Subd. 10b. **Remote supervision.** "Remote supervision" means:

(b) A specialty practitioner in a hard-to-fill faculty position who has been employed at the College of Veterinary Medicine, University of Minnesota, for five years or more prior to 2003 or is specialty board certified by the American Veterinary Medical Association or the European Board of Veterinary Specialization may be granted a specialty faculty Veterinary Medical Center clinician license which will allow the licensee to practice veterinary medicine in the state of Minnesota in the specialty area of the licensee's training and only within the scope of employment at the Veterinary Medical Center.

(c) A specialty practitioner in a hard-to-fill faculty position at the College of Veterinary Medicine, University of Minnesota, who has graduated from a board-approved foreign veterinary school may be granted a temporary faculty Veterinary Medical Center clinician license. The temporary faculty Veterinary Medical Center clinician license expires in two years and allows the licensee to practice veterinary medicine as defined in subdivision 1 and treat animals owned by clients of the Veterinary Medical Center. The temporary faculty Veterinary Medical Center clinician license allows the licensee to practice veterinary medicine in the state of Minnesota in the specialty area of the licensee's training and only within the scope of employment at the Veterinary Medical Center while under the direct supervision of a veterinarian currently licensed and actively practicing veterinary medicine in Minnesota, as defined in section 156.04. The direct supervising veterinarian must not have any current or past conditions, restrictions, or probationary status imposed on the veterinarian's license by the board within the past five years. The holder of a temporary faculty Veterinary Medical Center clinician license who is enrolled in a PhD program may apply for up to two additional consecutive two-year extensions of an expiring temporary faculty Veterinary Medical Center clinician license. Any other holder of a temporary faculty Veterinary Medical Center clinician license may apply for one two-year extension of the expiring temporary faculty Veterinary Medical Center clinician license. Temporary faculty Veterinary Medical Center clinician licenses that are allowed to expire may not be renewed. The board shall grant an extension to a licensee who demonstrates suitable progress toward completing the requirements of their academic program, specialty board certification, or full licensure in Minnesota by a graduate of a foreign veterinary college.

(d) Temporary and specialty faculty Veterinary Medical Center clinician licensees must abide by all the laws governing the practice of veterinary medicine in the state of Minnesota and are subject to the same disciplinary action as any other veterinarian licensed in the state of Minnesota.

(e) The fee for a license issued under this subdivision is the same as for a regular license to practice veterinary medicine in Minnesota. License payment deadlines, late payment fees, and other license requirements are also the same as for regular licenses.
