1.6	Subdivision 1. Graduation requirements. (a) Students beginning 9th grade in the
1.7	2011-2012 school year and later must successfully complete the following high school level

1.9	(1) four credits of language arts sufficient to satisfy all of the academic standards in
1.10	English language arts;
1.11	(2) three credits of mathematics, including an algebra II credit or its equivalent, sufficient
1.12	to satisfy all of the academic standards in mathematics;
1.13	(3) an algebra I credit by the end of 8th grade sufficient to satisfy all of the 8th grade

- (b) A school district is encouraged to offer a course for credit in government and citizenship to 11th or 12th grade students who begin 9th grade in the 2020-2021 school year and later, that satisfies the government and citizenship requirement in paragraph (a), clause (5).
