1.2relating to capital investment; modifying and correcting appropriations of general

1.3obligation bond proceeds; amending Laws 2014, chapter 294, article 1, sections

1.44, subdivision 3; 15, subdivision 2; 18, subdivision 4; 21, subdivision 10.

1.5BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6Section 1. Laws 2014, chapter 294, article 1, section 4, subdivision 3, is amended to

1.8Subd. 3. **Library Construction Grants**2,000,000

1.9(a) For library construction grants under

1.10Minnesota Statutes, section 134.45.

1.11(b) \$570,000 of this appropriation is for a

1.12grant to the city of Jackson to predesign,

1.13design, construct, furnish, and equip the

1.14renovation and expansion of the city library.

1.15This appropriation is not available until the

1.16commissioner of management and budget

1.17determines that at least an equal amount has

1.18been committed to the project from nonstate

1.19sources.

1.20(c) \$257,000 of this appropriation is for a

1.21grant to the city of Perham to predesign,

1.22design, construct, furnish, and equip

1.23the renovation of the city library. This

2.1 appropriation is not available until the
2.2 commissioner of management and budget
2.3 determines that at least an equal amount has
2.4 been committed to the project from nonstate
2.5 sources.

2.6 (d) \$50,000 of this appropriation is from the
2.7 general fund and is for a grant to the city of
2.8 Bagley for capital improvements to the city's
2.9 library. This appropriation is not available
2.10 until the commissioner of management and
2.11 budget determines that at least an equal
2.12 amount has been committed to the project
2.13 from nonstate sources.

2.14 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.16 Subd. 2. **Cottage Grove - HERO Center** 1,460,000

2.17 For a grant to the city of Cottage Grove to
2.18 predesign and design a Health and Emergency
2.19 Response Occupations (HERO) Center at
2.20 12600 Ravine Parkway in Cottage Grove.
2.21 This appropriation is not available until the
2.22 commissioner of management and budget
2.23 determines that the city of Cottage Grove and
2.24 the Board of Trustees of the Minnesota State
2.25 Colleges and Universities have entered into
2.26 an agreement for operation and management
2.27 of the center, ~~and that at least an equal amount~~
2.28 ~~is committed to the project from nonstate~~
2.29 ~~sources.~~ This appropriation does not require
2.30 any contribution from nonstate sources.

 3.4 for grants under Minnesota Statutes, section
 3.5 256E.37, to construct and rehabilitate early
 3.6 childhood learning and child protection
 3.7 facilities. Notwithstanding the limits on
 3.8 grant amounts in Minnesota Statutes, section
 3.9 256E.37, one grant from this appropriation
 3.10 for an individual facility may be for up to
 3.11 \$1,000,000.

3.12 (b) Notwithstanding the limitations on grant
 3.13 amounts and requirements for geographic
 3.14 distribution in Minnesota Statutes, section
 3.15 256E.37, or this subdivision, \$3,000,000 of
 3.16 this appropriation is for a grant to Hennepin
 3.17 County to predesign, design, renovate,
 3.18 furnish, and equip the early childhood
 3.19 center at the YWCA of Minneapolis, and to
 3.20 improve the building's heating, ventilation,
 3.21 air conditioning systems, the sprinkler
 3.22 system, and the pool walls and ceiling. The
 3.23 grant to Hennepin County is not available
 3.24 until the commissioner of management and
 3.25 budget determines that at least an equal
 3.26 amount has been committed to the project
 3.27 from nonstate sources.
