A bill for an act

1.1 relating to motor vehicles; modifying provisions related to pickup trucks;
1.2 amending Minnesota Statutes 2010, sections 168.002, subdivisions 24, 26, 40, by
1.3 adding subdivisions; 168.021, subdivision 1; 168.12, subdivisions 1, 2, 2b, 2c,
1.4 2d, 2e; 168.123, subdivision 1; 168.1235, subdivision 1; 168.124, subdivision
1.5 1; 168.125, subdivision 1; 168.1253, subdivision 1; 168.1255, subdivision 1;
1.6 168.129, subdivision 1; 168.1296, subdivision 1; 168.1298, subdivision 1; Laws
1.7 2008, chapter 350, article 1, section 5, as amended.

1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. Minnesota Statutes 2010, section 168.002, is amended by adding a
1.11 subdivision to read:

1.12 Subd. 21a. **Noncommercial vehicle.** "Noncommercial vehicle" means a one-ton
1.13 pickup truck registered under section 168.013, subdivision 1e, with a 15,000 pounds or
1.14 less gross vehicle weight rating and for which the owner has made a declaration that the
1.15 vehicle will be operated exclusively for personal use. The declaration must be based
1.16 on one or more of the following:

- 1.17 (1) a change of vehicle use;
1.18 (2) registration of a new vehicle;
1.19 (3) transfer of vehicle ownership; or
1.20 (4) registration renewal.

1.21 Sec. 2. Minnesota Statutes 2010, section 168.002, is amended by adding a subdivision
1.22 to read:

1.23 Subd. 21b. **One-ton pickup truck.** "One-ton pickup truck" means any truck
1.24 resembling a pickup truck with a manufacturer's nominal rated carrying capacity of one
1.25 ton. If the manufacturer's nominal rated carrying capacity is not provided or is not known,

2.4 of Federal Regulations, title 49, section 390.5.

2.5 Sec. 3. Minnesota Statutes 2010, section 168.002, subdivision 24, is amended to read:

2.6 Subd. 24. **Passenger automobile.** (a) "Passenger automobile" means any motor
2.7 vehicle designed and used for carrying not more than 15 individuals, including the driver.

2.8 (b) "Passenger automobile" does not include motorcycles, motor scooters, buses,
2.9 school buses, or commuter vans as defined in section 168.126. ~~Except as provided in~~
2.10 ~~paragraph (c), clause (1), a vehicle with a gross vehicle weight rating of 9,000 to 13,000~~
2.11 ~~pounds that is a pickup truck or a van is not a passenger automobile.~~

2.12 (c) "Passenger automobile" includes, but is not limited to:

2.13 (1) a vehicle that is (i) a pickup truck or a van, ~~(ii) not used in furtherance of a~~
2.14 ~~commercial enterprise, and (iii) not subject to state or federal regulation as a commercial~~
2.15 ~~motor vehicle as defined in subdivisions 26 and 40;~~

2.16 (2) neighborhood electric vehicles, as defined in section 169.011, subdivision 47; and

2.17 (3) medium-speed electric vehicles, as defined in section 169.011, subdivision 39.

2.18 Sec. 4. Minnesota Statutes 2010, section 168.002, subdivision 26, is amended to read:

2.19 Subd. 26. **Pickup truck.** "Pickup truck" means any truck with a manufacturer's
2.20 nominal rated carrying capacity of three-fourths ton or less and commonly known as a
2.21 pickup truck. If the manufacturer's nominal rated carrying capacity is not provided or
2.22 cannot be determined, then the value specified by the manufacturer as the gross vehicle
2.23 weight as indicated on the manufacturer's certification label must be less than 10,000
2.24 pounds.

2.25 Sec. 5. Minnesota Statutes 2010, section 168.002, subdivision 40, is amended to read:

2.26 Subd. 40. **Van.** "Van" means any vehicle of box-like design with no barrier or
2.27 separation between the operator's area and the remainder of the cargo-carrying area, and
2.28 with a manufacturer's nominal rated carrying capacity of three-fourths ton or less. If
2.29 the manufacturer's nominal rated carrying capacity is not provided or not known, then
2.30 the value specified by the manufacturer as the maximum gross weight or gross vehicle
2.31 weight rating as indicated on the manufacturer's certification label must be less than
2.32 10,000 pounds.

3.1 Sec. 6. Minnesota Statutes 2010, section 168.021, subdivision 1, is amended to read:

3.2 Subdivision 1. **Disability plates; application.** (a) When a motor vehicle registered
3.3 under section 168.017, a motorcycle as defined in section 168.002, subdivision 19, a truck
3.4 ~~having a manufacturer's nominal rated capacity of one ton and resembling a pickup truck,~~
3.5 a one-ton pickup truck as defined in section 168.002, subdivision 21b, or a self-propelled
3.6 recreational vehicle as defined in section 168.002, subdivision 27, is owned or primarily
3.7 operated by a permanently physically disabled person or a custodial parent or guardian
3.8 of a permanently physically disabled minor, the owner may apply for and secure from
3.9 the commissioner (1) immediately, a temporary permit valid for 30 days if the applicant
3.10 is eligible for the disability plates issued under this section and (2) two disability plates
3.11 with attached emblems, one plate to be attached to the front, and one to the rear of the

3.19 (d) No medical statement or proof of disability is required when an owner of a motor
3.20 vehicle applies for plates for one or more motor vehicles that are specially modified for
3.21 and used exclusively by permanently physically disabled persons.

3.22 (e) The owner of a motor vehicle may apply for and secure (i) immediately, a permit
3.23 valid for 30 days, if the applicant is eligible to receive the disability plates issued under
3.24 this section, and (ii) a set of disability plates for a motor vehicle if:

3.25 (1) the owner employs a permanently physically disabled person who would qualify
3.26 for disability plates under this section; and

3.27 (2) the owner furnishes the motor vehicle to the physically disabled person for the
3.28 exclusive use of that person in the course of employment.

3.30 Subdivision 1. **Plates; design, visibility, periods of issuance.** (a) The commissioner,
3.31 upon approval and payment, shall issue to the applicant the plates required by this chapter,
3.32 bearing the state name and an assigned vehicle registration number. The number assigned
3.33 by the commissioner may be a combination of a letter or sign with figures. The color of the
3.34 plates and the color of the abbreviation of the state name and the number assigned must

4.4 must clearly indicate by letters or other suitable insignia the maximum gross weight
4.5 for which the tax has been paid.

4.6 (c) Plates issued to a noncommercial vehicle as defined in section 168.002,
4.7 subdivision 21a, must bear the inscription "noncommercial" unless the vehicle is
4.8 displaying a special plate authorized and issued under this chapter.

4.9 (d) A one-ton pickup truck, as defined in section 168.002, subdivision 21b, that is
4.10 used for commercial purposes and is subject to section 168.185, is eligible to display
4.11 special plates as authorized and issued under this chapter.

4.12 ~~(e)~~ (e) The plates must be so treated as to be at least 100 times brighter than the
4.13 conventional painted number plates. When properly mounted on an unlighted vehicle, the
4.14 plates, when viewed from a vehicle equipped with standard headlights, must be visible for
4.15 a distance of not less than 1,500 feet and readable for a distance of not less than 110 feet.

4.16 ~~(f)~~ (f) The commissioner shall issue plates for the following periods:

4.17 (1) New plates issued pursuant to section 168.012, subdivision 1, must be issued to a
4.18 vehicle for as long as the vehicle is owned by the exempt agency and the plate shall not be
4.19 transferable from one vehicle to another but the plate may be transferred with the vehicle
4.20 from one tax-exempt agency to another.

4.21 (2) Plates issued for passenger automobiles must be issued for a seven-year period.
4.22 All plates issued under this paragraph must be replaced if they are seven years old or older
4.23 at the time of registration renewal or will become so during the registration period.

4.24 (3) Plates issued under sections 168.053 and 168.27, subdivisions 16 and 17, must
4.25 be for a seven-year period.

4.26 (4) Plates issued under subdivisions 2c and 2d and section 168.123 must be issued
4.27 for the life of the veteran under section 169.79.

4.28 (5) Plates for any vehicle not specified in clauses (1) to (3) must be issued for the
4.29 life of the vehicle.

4.30 ~~(g)~~ (g) In a year in which plates are not issued, the commissioner shall issue for each
4.31 registration a sticker to designate the year of registration. This sticker must show the year
4.32 or years for which the sticker is issued, and is valid only for that period. The plates and
4.33 stickers issued for a vehicle may not be transferred to another vehicle during the period
4.34 for which the sticker is issued, except when issued for a vehicle registered under section
4.35 168.187.

5.30 information as the commissioner considers necessary, for each of the motor vehicles.

6.5 Subd. 2b. **Firefighters; special plates, rules.** (a) The commissioner shall issue
6.6 special plates, or a single license plate in the case of a motorcycle plate, to any applicant
6.7 who:

6.8 (1) is a member of a fire department receiving state aid under chapter 69, has a
6.9 letter from the fire chief, and is an owner of a passenger automobile, ~~a truck with a~~
6.10 ~~manufacturer's nominal rated capacity of one ton and resembling a pickup truck~~ as defined
6.11 in section 168.002, subdivision 24, a one-ton pickup truck as defined in section 168.002,
