1.8	Subdivision 1. Return required. (a) In the case of a decedent who has an interest in
1.9	property with a situs in Minnesota, the personal representative must submit a Minnesota
1.10	estate tax return to the commissioner, on a form prescribed by the commissioner, if:
1.11	(1) a federal estate tax return is required to be filed; or
1.12	(2) the sum of the federal gross estate and federal adjusted taxable gifts, as defined in
1.13	section 2001(b) of the Internal Revenue Code, made within three years of the date of the
1.14	decedent's death exceeds \$1,200,000 for estates of decedents dying in 2014; \$1,400,000 for
1.15	estates of decedents dying in 2015; \$1,600,000 for estates of decedents dying in 2016;

Subdivision 1. **Tax amount.** The tax imposed must be computed by applying to the Minnesota taxable estate the following schedule of rates and then <u>multiplying</u> the resulting amount <del>multiplied</del> by a fraction, not greater than one, the numerator of which is the value of the Minnesota gross estate plus the value of gifts under section 291.016, subdivision 2, clause (3), with a Minnesota situs, and the denominator of which is the federal gross estate plus the value of gifts under section 291.016, subdivision 2, clause (3):

# Subd. 1e. Election of portability of deceased spousal unused exclusion amounts; election irrevocable; deemed elections. (a) A personal representative of a decedent's estate may elect, on a return required under section 289A.10, subdivision 1, to allow a decedent's surviving spouse to take into account the decedent's deceased spousal unused exclusion amount, as provided in section 291.016, subdivision 3, paragraph (b).

4.1	(b) In order for a surviving spouse to take into account the decedent's deceased spousal
4.2	unused exclusion amount as provided in section 291.016, subdivision 3, paragraph (b), a
4.3	personal representative of a decedent's estate must file a return and make the portability

4.5	under section 289A.10, subdivision 1.

- (c) An election under paragraph (a) or (b) is irrevocable. The personal representative of a decedent's estate must state affirmatively on the return that the decedent's estate is electing portability. The commissioner may prescribe the form of the election on the return.
