- 2.1 The amount of a financial stipend must not exceed a grant applicant's recognized cost of attendance, as defined in subdivision 6, after deducting the following:
- 2.3 (1) the assigned student responsibility of at least 50 percent of the cost of attending the institution of the applicant's choosing described in paragraph (a);
- 2.5 (2) the assigned family responsibility as defined in section 136A.101; and
- 2.6 (3) the amount of a federal Pell grant award for which the grant applicant is eligible.
- The minimum financial stipend is \$100 per academic year.
