1.1 A bill for an act
 1.2 relating to human services; providing for a rate increase for certain providers;
 1.3 amending Minnesota Statutes 2014, sections 256B.0625, subdivision 38;
 1.4 256B.763.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2014, section 256B.0625, subdivision 38, is amended to
 1.7 read:

1.8 Subd. 38. **Payments for mental health services.** ~~Payments for mental~~
 1.9 ~~health services covered under the medical assistance program that are provided by~~
 1.10 ~~masters-prepared mental health professionals shall be 80 percent of the rate paid to~~
 1.11 ~~doctoral-prepared professionals.~~ Payments for mental health services covered under
 1.12 the medical assistance program that are provided by masters-prepared mental health
 1.13 professionals ~~employed by community mental health centers~~ shall be 100 percent of the
 1.14 rate paid to doctoral-prepared professionals. Payments for mental health services covered
 1.15 under the medical assistance program that are provided by physician assistants shall be
 1.16 80.4 percent of the base rate paid to psychiatrists.

1.17 Sec. 2. Minnesota Statutes 2014, section 256B.763, is amended to read:

1.18 **256B.763 CRITICAL ACCESS MENTAL HEALTH RATE INCREASE.**

1.19 (a) For services defined in paragraph (b) and rendered on or after July 1, ~~2007~~ 2015,
 1.20 payment rates shall be increased by ~~23.7~~ ten percent over the rates in effect on January
 1.21 1, ~~2006~~ 2015, for:

- 1.22 (1) psychiatrists and advanced practice registered nurses with a psychiatric specialty;
 1.23 (2) community mental health centers under section 256B.0625, subdivision 5; ~~and~~

2.1 (3) mental health clinics and centers certified under Minnesota Rules, parts
2.2 9520.0750 to 9520.0870, or hospital outpatient psychiatric departments that are designated
2.3 as essential community providers under section 62Q.19; and

2.4 (4) all other mental health professionals providing a covered service under sections
2.5 256B.0624 and 256B.0625.

2.6 (b) This increase applies to group skills training when provided as a component of
2.7 children's therapeutic services and support, psychotherapy, medication management,
2.8 evaluation and management, diagnostic assessment, explanation of findings, psychological
2.9 testing, neuropsychological services, direction of behavioral aides, and inpatient
2.10 consultation.

2.11 (c) This increase does not apply to rates that are governed by section 256B.0625,
2.12 subdivision 30, or 256B.761, paragraph (b), other cost-based rates, rates that are
2.13 negotiated with the county, rates that are established by the federal government, or rates
2.14 that increased between January 1, 2004, and January 1, 2005.

2.15 (d) The commissioner shall adjust rates paid to prepaid health plans under contract
2.16 with the commissioner to reflect the rate increases provided in paragraphs (a), (e), and
2.17 (f). The prepaid health plan must pass this rate increase to the providers identified in
2.18 paragraphs (a), (e), (f), and (g).

2.19 (e) Payment rates shall be increased by 23.7 percent over the rates in effect on
2.20 December 31, 2007, for:

2.21 (1) medication education services provided on or after January 1, 2008, by adult
2.22 rehabilitative mental health services providers certified under section 256B.0623; and

2.23 (2) mental health behavioral aide services provided on or after January 1, 2008, by
2.24 children's therapeutic services and support providers certified under section 256B.0943.

2.25 (f) For services defined in paragraph (b) and rendered on or after January 1, 2008, by
2.26 children's therapeutic services and support providers certified under section 256B.0943
2.27 and not already included in paragraph (a), payment rates shall be increased by 23.7 percent
2.28 over the rates in effect on December 31, 2007.

2.29 (g) Payment rates shall be increased by 2.3 percent over the rates in effect on
2.30 December 31, 2007, for individual and family skills training provided on or after January
2.31 1, 2008, by children's therapeutic services and support providers certified under section
2.32 256B.0943.
