1.7	Section 1. Minnesota Statutes 2010, section 169.06, subdivision 4, is amended to read:

Subd. 4. Obedience to traffic-control signal or flagger; presumptions. (a) The 1.8 driver of any vehicle shall obey the instructions of any official traffic-control device 1.9 applicable thereto placed in accordance with the provisions of this chapter, unless 1.10 otherwise directed by a police officer or by a certified overdimensional load escort driver 1 11 flagger authorized under this subdivision, subject to the exceptions granted the driver of 1.12 an authorized emergency vehicle in this chapter. 1.13 (b) No provision of this chapter for which official traffic-control devices are required 1.14 shall be enforced against an alleged violator if at the time and place of the alleged 1.15 violation an official device is not in proper position and sufficiently legible to be seen by 1.16

an ordinarily observant person. Whenever a particular section does not state that official
traffic-control devices are required, such section shall be effective even though no devices
are erected or in place.

(c) Whenever official traffic-control devices are placed in position approximately
conforming to the requirements of this chapter, such devices shall be presumed to have
been so placed by the official act or direction of lawful authority, unless the contrary
shall be established by competent evidence.

(d) Any official traffic-control device placed pursuant to the provisions of thischapter and purporting to conform to the lawful requirements pertaining to such devices

shall be presumed to comply with the requirements of this chapter, unless the contraryshall be established by competent evidence.

- (e) A flagger in a designated work zone may stop vehicles and hold vehicles in place
 until it is safe for the vehicles to proceed. A person operating a motor vehicle that has
 been stopped by a flagger in a designated work zone may proceed after stopping only on
 instruction by the flagger.
- (f) An overdimensional load escort driver with a certificate issued under section
 2.8 299D.085, while acting as a flagger escorting a legal overdimensional load, may stop
 vehicles and hold vehicles in place until it is safe for the vehicles to proceed. A person
 operating a motor vehicle that has been stopped by an escort driver acting as a flagger may
 proceed only on instruction by the flagger or a police officer.
- (g) A person may stop and hold vehicles in place until it is safe for the vehicles 2.12 to proceed, if the person: (1) holds a motorcycle road guard certificate issued under 2.13 section 171.60; (2) meets the safety and equipment standards for operating under the 2.14 2.15 certificate; and (3) is acting as a flagger escorting a motorcycle group ride. A flagger operating as provided under this paragraph may direct operators of motorcycles within a 2.16 motorcycle group ride or other vehicle traffic, notwithstanding any contrary indication of a 2.17 traffic-control device, including stop signs or traffic-control signals. A person operating 2.18 a vehicle that has been stopped by a flagger under this paragraph may proceed only on 2.19 instruction by the flagger or a police officer. 2.20 (h) A person representing a motorcycle group ride in any city of the first class may 2.21 no later than seven days before the ride request of the city's police chief that traffic and 2.22 traffic signals be controlled or modified to allow the ride to proceed through a specified 2.23 route at a specified time without stopping. The police chief shall no later than three days 2.24 before the ride notify the organizer as to whether the city will control traffic as requested 2.25 2.26 at no cost to the organizer. If the city chooses not to control traffic as requested at no cost
