21.28 Subdivision 1. **Scope.** For the purposes of this chapter, the terms defined in this
21.29 section have the meanings given them.

21.30 Subd. 3. **Commissioner.** "Commissioner" means the commissioner of human
21.31 services or the commissioner's designee.

21.32 Subd. 4. **Committed person.** "Committed person" means an individual committed
21.33 under this chapter, or under this chapter and under section 253B.18, as mentally ill and

22.1 dangerous. It does not include person's committed only as mentally ill and dangerous under

25.6 action for persons previously committed under Minnesota Statutes, chapter 253B, or its

25.9 The revisor of statutes shall renumber each section of Minnesota Statutes listed in
