1.1 relating to natural resources; providing for taking wolf; modifying predator  
1.2 control program; appropriating money; amending Minnesota Statutes 2010,  
1.3 sections 97A.015, subdivision 53; 97A.451, subdivision 3; 97A.473, subdivisions  
1.4 3, 5, 5a; 97A.475, subdivisions 2, 3, 20; 97B.031, subdivisions 1, 2; 97B.035,  
1.5 subdivision 1a; 97B.601, subdivisions 3a, 4; 97B.603; 97B.605; 97B.671,  
1.6 subdivision 4; 97B.901; Minnesota Statutes 2011 Supplement, sections 97A.075,  
1.7 by adding a subdivision; 97B.075; 97B.645, subdivision 9; proposing coding for  
1.8 new law in Minnesota Statutes, chapter 97B; repealing Minnesota Statutes 2010,

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2010, section 97A.015, subdivision 53, is amended to  
1.13 read:

1.14 Subd. 53. **Unprotected wild animals.** "Unprotected wild animals" means wild  
1.15 animals that are not protected wild animals including weasel, coyote (~~brush-wolf~~), gopher,  
1.16 porcupine, striped skunk, and unprotected birds.

1.17 Sec. 2. Minnesota Statutes 2011 Supplement, section 97A.075, is amended by adding a  
1.18 subdivision to read:

1.19 Subd. 7. **Wolf licenses.** (a) For purposes of this subdivision, "wolf license" means a  
1.20 license or permit issued under section 97A.475, subdivision 2, clause (16); 3, paragraph  
1.21 (a), clause (13); or 20, paragraph (b).

1.22 (b) Revenue from wolf licenses must be credited to the wolf management and  
1.23 monitoring account and is appropriated to the commissioner only for wolf management,  
1.24 research, damage control, enforcement, and education.

1.25 Sec. 3. Minnesota Statutes 2010, section 97A.451, subdivision 3, is amended to read:

2.1 Subd. 3. **Residents under age 16; small game.** (a) A resident under age 16 must  
2.2 obtain a small game license in order to take small game by firearms or bow and arrow  
2.3 without paying the applicable fees under section 97A.475, subdivisions 2, 4, and 5, if  
2.4 the resident is:

2.5 (1) age 14 or 15 and possesses a firearms safety certificate;

2.6 (2) age 13, possesses a firearms safety certificate, and is accompanied by a parent or  
2.7 guardian;

2.8 (3) age 13, 14, or 15, possesses an apprentice hunter validation, and is accompanied  
2.9 by a parent or guardian who possesses a small game license that was not obtained using an  
2.10 apprentice hunter validation; or

2.11 (4) age 12 or under and is accompanied by a parent or guardian.

2.12 (b) A resident under age 16 may take small game, other than wolves, by trapping  
2.13 without a small game license, but a resident 13 years of age or older must have a trapping  
2.14 license. A resident under age 13 may trap small game, other than wolves, without a  
2.15 trapping license, but may not register fisher, otter, bobcat, or pine marten unless the  
2.16 resident is at least age five. Any fisher, otter, bobcat, or pine marten taken by a resident  
2.17 under age five must be included in the limit of the accompanying parent or guardian.

2.18 (c) A resident under age 12 may apply for a turkey license and may take a turkey  
2.19 without a firearms safety certificate if the resident is accompanied by an adult parent or  
2.20 guardian who has a firearms safety certificate.

2.21 (d) A resident under age 12 may apply for a prairie chicken license and may take a  
2.22 prairie chicken without a firearms safety certificate if the resident is accompanied by an  
2.23 adult parent or guardian who has a firearms safety certificate.

2.25 Subd. 3. **Lifetime small game hunting license; fee.** (a) A resident lifetime small

2.27 in the state. The license authorizes those hunting and trapping activities authorized by the  
2.28 annual resident small game hunting ~~and trapping licenses~~ license and the trapping license

6.1 (a) A person may not take protected wild animals, except raccoon and fox, with  
6.2 a firearm between the evening and morning times established by commissioner's rule,  
6.3 except as provided in this section.

6.4 (b) Big game and wolves may be taken from one-half hour before sunrise until  
6.5 one-half hour after sunset.

6.6 (c) Except as otherwise prescribed by the commissioner on or before the Saturday  
6.7 nearest October 8, waterfowl may be taken from one-half hour before sunrise until sunset  
6.8 during the entire season prescribed by the commissioner.

6.29 (a) While two or more persons are taking small game as a party and maintaining  
6.30 unaided visual and vocal contact, a member of the party may take and possess more than  
6.31 one limit of small game, but the total number of small game taken and possessed by  
6.32 the party may not exceed the limit of the number of persons in the party that may take  
6.33 and possess small game.

7.1           (b) This section does not apply to ~~the~~ hunting ~~of~~ wolves, migratory game birds, or  
7.2 turkeys, except that a licensed turkey hunter may assist another licensed turkey hunter and

7.13           Subd. 9. **Open season.** There shall be no open season for ~~gray~~ wolves until after the  
7.14 ~~gray~~ wolf is delisted under the federal Endangered Species Act of 1973. After that time,  
7.15 the commissioner may prescribe open seasons and restrictions for taking ~~gray~~ wolves but  
7.16 must provide opportunity for public comment.

7.18           Subdivision 1. **License required.** Except as provided under section 97B.645 or  
7.19 97B.671, a person may not take a wolf without a wolf hunting or wolf trapping license.

7.20           Subd. 2. **Open seasons.** Wolves may be taken with legal firearms, with bow and  
7.21 arrow, and by trapping. The commissioner may by rule prescribe the open seasons for  
7.22 wolves.

7.23           Subd. 3. **Open areas.** The commissioner may by rule designate areas where wolves  
7.24 may be taken.

7.25           Subd. 4. **Daily and possession limits.** The commissioner may establish by rule  
7.26 the daily and possession limits for wolves.

7.27           Subd. 5. **Limit on number of hunters and trappers.** The commissioner may by  
7.28 rule limit the number of persons that may hunt or trap wolves in an area, if it is necessary  
7.29 to prevent an overharvest or improve the distribution of hunters and trappers. The  
7.30 commissioner shall establish a method, including a drawing, to impartially select the  
7.31 hunters and trappers for an area.

7.32           Subd. 6. **Application for license.** An application for a wolf hunting or trapping  
7.33 license must be made in a manner provided by the commissioner and accompanied by

8.1 a \$4 application fee. The \$4 application fee is appropriated to pay for costs associated  
8.2 with conducting the wolf license drawing and wolf management. A person may not make  
8.3 more than one application for each season as prescribed by the commissioner. If a person  
8.4 makes more than one application, the person is ineligible for a license for that season after  
8.5 determination by the commissioner, without a hearing.

8.6 Subd. 7. **Quotas.** The commissioner may by rule set an annual quota for the  
8.7 number of wolves that can be taken by hunting and trapping. The commissioner may  
8.8 establish a method to monitor harvest and close the season when the quota is reached. The  
8.9 commissioner shall reserve a portion of the annual quota for the trapping season.

8.10 Sec. 20. Minnesota Statutes 2010, section 97B.671, subdivision 4, is amended to read:

8.11 Subd. 4. **Gray Wolf control.** (a) The commissioner shall provide a ~~gray~~ wolf control  
8.12 training program for certified predator controllers participating in ~~gray~~ wolf control.

8.13 (b) After the ~~gray~~ wolf is delisted under the federal Endangered Species Act of  
8.14 1973, in zone B, as defined under section 97B.645, subdivision 12, if the commissioner,  
8.15 after considering recommendations from an extension agent or conservation officer, has  
8.16 verified that livestock, domestic animals, or pets were destroyed by a ~~gray~~ wolf within the  
8.17 previous five years, and if the livestock, domestic animal, or pet owner requests ~~gray~~ wolf  
8.18 control, the commissioner shall open a predator control area for ~~gray~~ wolves.

8.19 (c) After the ~~gray~~ wolf is delisted under the federal Endangered Species Act of  
8.20 1973, in zone A, as defined under paragraph (g), if the commissioner, after considering  
8.21 recommendations from an extension agent or conservation officer, verifies that livestock,  
8.22 domestic animals, or pets were destroyed by a ~~gray~~ wolf, and if the livestock, domestic  
8.23 animal, or pet owner requests ~~gray~~ wolf control, the commissioner shall open a predator  
8.24 control area for ~~gray~~ wolves for up to 60 days.

8.25 (d) A predator control area opened for ~~gray~~ wolves may not exceed a one-mile  
8.26 radius surrounding the damage site.

8.27 (e) The commissioner shall pay a certified ~~gray~~ wolf predator controller ~~\$150~~ the  
8.28 amount the commissioner determines by written order published in the State Register for  
8.29 each wolf taken. The certified ~~gray~~ wolf predator controller must dispose of unsalvageable  
8.30 remains as directed by the commissioner. All salvageable ~~gray~~ wolf remains must be  
8.31 surrendered to the commissioner. The fees are not subject to the rulemaking provisions of  
8.32 chapter 14, and section 14.386 does not apply.

8.33 (f) The commissioner may, in consultation with the commissioner of agriculture,  
8.34 develop a cooperative agreement for ~~gray~~ wolf control activities with the United States  
8.35 Department of Agriculture. The cooperative agreement activities may include, but not be

9.1 limited to, ~~gray~~ wolf control, training for state predator controllers, and control monitoring  
9.2 and record keeping.

9.3 (g) For the purposes of this subdivision, "zone A" means that portion of the state  
9.4 lying outside of zone B, as defined under section 97B.645, subdivision 12.

9.5 Sec. 21. Minnesota Statutes 2010, section 97B.901, is amended to read:

9.6 **97B.901 REGISTRATION AND TAGGING OF FUR-BEARING ANIMALS.**

9.7 (a) The commissioner may, by rule, require persons taking, possessing, and  
9.8 transporting fur-bearing animals to tag the animals. The commissioner shall prescribe  
9.9 the manner of issuance and the type of tag, which must show the year of issuance. The  
9.10 commissioner shall issue the tag, without a fee, upon request.

9.11 (b) The pelt of each bobcat, fisher, pine marten, ~~and~~ otter, and wolf must be  
9.12 presented, by the person taking it, to a state wildlife manager designee for registration  
9.13 before the pelt is sold and before the pelt is transported out of the state, but in no event  
9.14 more than 48 hours after the season closes for the species.

9.15 (c) The whole carcass of each wolf, with the pelt removed, must be presented by the  
9.16 person taking it to a state wildlife manager designee for registration before the pelt is sold  
9.17 and before the pelt is transported out of the state, but in no event more than 48 hours after  
9.18 the season closes. The commissioner may require that the entire carcass or samples from  
9.19 the carcass be surrendered to the state wildlife manager designee.

9.20 Sec. 22. **RULEMAKING; RESTITUTION VALUE FOR WOLVES.**

9.21 (a) The commissioner of natural resources shall amend the restitution value for  
9.22 gray wolves in Minnesota Rules, part 6133.0075, to be \$500 and shall change the term  
9.23 "gray wolves" to "wolves."

9.24 (b) The commissioner may use the good cause exemption under Minnesota Statutes,  
9.25 section 14.388, subdivision 1, clause (3), to adopt rules under this section, and Minnesota  
9.26 Statutes, section 14.386, does not apply except as provided under Minnesota Statutes,  
9.27 section 14.388.

9.28 Sec. 23. **RULEMAKING; USE OF SNARES.**

9.29 (a) The commissioner of natural resources shall add a definition of a wolf snare to  
9.30 Minnesota Rules, part 6234.0900, to read: "'Wolf snare' means any snare set that:

9.31 A. has a maximum loop diameter greater than ten inches, but less than or equal  
9.32 to 18 inches;

9.33 B. has a cable diameter of at least 7/64 inches;

10.1 C. includes stops affixed to the cable to ensure that the portion of the snare that  
10.2 makes up the noose loop may not be less than three inches in diameter when fully closed;

10.3 D. includes a breakaway device that would cause the snare loop to break when  
10.4 pulled by a moose; and

10.5 E. includes a diverter wire that extends 27 inches in both directions, measured  
10.6 perpendicular to and from the top of the snare loop. The diverter wires must be positioned  
10.7 at an angle no more than 20 degrees from the horizontal plane of the top of the snare, and  
10.8 the snare must be set within 20 yards of bait."

10.9 (b) The commissioner of natural resources shall amend Minnesota Rules, part  
10.10 6234.2300, to include a subpart to read: "Wolves may be taken with snares or wolf snares  
10.11 as defined in part 6234.0900."

10.12 (c) The commissioner of natural resources shall amend Minnesota Rules, part  
10.13 6234.2400, subpart 7, to read: "A snare may not be set so that the top of the loop is more  
10.14 than 20 inches above the first surface beneath the bottom of the set snare loop. During  
10.15 the wolf season, licensed wolf trappers may use wolf snares but a wolf snare may not be  
10.16 set so that the bottom of the loop is more than 18 inches above the first surface beneath  
10.17 the bottom of the set snare loop."

10.18 (d) The commissioner of natural resources shall amend Minnesota Rules, part  
10.19 6234.2400, subpart 5, to read: "Snares, including wolf snares, may not be set in deer,  
10.20 elk, or moose trails."

10.21 (e) The commissioner of natural resources shall amend Minnesota Rules, part  
10.22 6234.2400, to include a subpart to read: "Licensed wolf trappers shall set wolf snares for  
10.23 wolves no closer than 500 feet to another wolf snare set by the same licensed wolf trapper."

10.24 (f) The commissioner may use the good cause exemption under Minnesota Statutes,  
10.25 section 14.388, subdivision 1, clause (3), to adopt rules under this section, and Minnesota  
10.26 Statutes, section 14.386, does not apply, except as provided under Minnesota Statutes,  
10.27 section 14.388.

10.28 **Sec. 24. 2012 FIREARMS WOLF SEASON.**

Repealed Minnesota Statutes: S1945-1

**97A.331 PENALTIES RELATED TO HUNTING.**

Subd. 7. **Gray wolf.** A person who takes, harasses, destroys, buys, sells, possesses, transports, or ships a gray wolf in violation of the game and fish laws is guilty of a gross misdemeanor.

**97B.645 GRAY WOLVES.**

Subd. 2. **Permit required to snare.** A person may not use a snare to take a wolf except under a permit from the commissioner.
