2.3 <u>Subdivision 1.</u> Powers. (a) The commissioner has all powers necessary to carry out
2.4 the duties specified in section 174.632. In the exercise of those powers, the commissioner
2.5 may:

2.7 all land and property necessary to preserve future passenger rail corridors or to construct,
