1.5	Section 1. ACCESSIBILITY FOR ARTS AND CULTURAL ECONOMY CAPITAL

1.7	Subdivision 1. Grant program established. The commissioner of employment and
1.8	economic development shall establish an arts and cultural economy capital grant program.
1.9	The commissioner shall make a grant to one or more intermediary organizations, to be
1.10	identified by the commissioner, to make grants to eligible grantees to fund necessary arts
1.11	or cultural facility building accessibility renovations to comply with Americans with
1.12	Disabilities Act (ADA) requirements and for capital projects at an arts or cultural facility.

\$50,000,000 in fiscal year 2024 is appropriated from the general fund to the commissioner of employment and economic development for accessibility for arts and cultural economy grants under section 1.
