- 1.1 A bill for an act
- 1.2 relating to insurance; establishing a task force on the cost of high deductible health
- 1.3 plans; prescribing duties; requiring a report; providing appointments; appropriating
- 1.4 money.
- 1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.6 Section 1. **TASK FORCE ON HIGH DEDUCTIBLE HEALTH PLANS.**
- 1.7 Subdivision 1. **Establishment.** The task force on high deductible health plans is
- 1.8 established to study issues related to the direct and indirect costs, including hidden costs,
- 1.9 of high deductible health plans.
- 1.10 Subd. 2. **Membership; meetings; staff.** (a) The task force is composed of the following
- 1.11 ten members, who must be appointed by July 1, 2017, and who serve at the pleasure of their
- 1.12 appointing authorities:
- 1.13 (1) the commissioner of commerce or a designee;
- 1.14 (2) the commissioner of health or a designee;
- 1.15 (3) the commissioner of Minnesota Management and Budget or a designee;
- 1.16 (4) two members of the house of representatives, one appointed by the speaker of the
- 1.17 house and one appointed by the minority leader;
- 1.18 (5) two members of the senate, one appointed by the majority leader and one appointed
- 1.19 by the minority leader;
- 1.20 (6) one person appointed by the Minnesota Council of Health Plans;

2.1 (7) three members appointed by the Minnesota Medical Group Management Association
2.2 to represent health care providers; and

2.3 (8) one health plan enrollee advocate, appointed by the commissioner of commerce.

2.4 (b) Compensation and expense reimbursement must be as provided under Minnesota
2.5 Statutes, section 15.059, subdivision 3, to members of the task force.

2.6 (c) The commissioner of commerce shall convene the task force by August 1, 2017, and
2.7 shall appoint a chair from the membership of the task force. Staffing and technical assistance
2.8 must be provided by the Department of Commerce.

2.9 Subd. 3. **Duties.** The task force shall review and discuss the following issues related to
2.10 the cost of high deductible health plans:

2.11 (1) initiatives states have taken to address the cost of high deductible health plans to
2.12 enrollees, health plans, and health care providers;

2.13 (2) initiatives insurers have taken to address the cost of high deductible health plans;

2.14 (3) the costs to health care providers incurred in collecting or attempting to collect
2.15 deductibles and co-pays on high deductible health plans;

2.16 (4) the annual amount of uncollected debt owed health care providers that is attributable
2.17 to high deductible health plans; and

2.18 (5) possible compensation mechanisms to reimburse health care providers for
2.19 uncompensated care in the form of uncollectible deductibles and co-pays on high deductible
2.20 plans.

2.21 Subd. 4. **Report.** By February 1, 2018, the task force must submit to the chairs and
2.22 ranking minority members of the house of representatives and senate committees and
2.23 divisions with primary jurisdiction over commerce and transportation its written
2.24 recommendations, including any draft legislation necessary to implement the
2.25 recommendations.

2.26 Subd. 5. **Expiration.** The task force expires the day after submitting the report under
2.27 subdivision 4, or February 2, 2018, whichever is earlier.

2.28 **Sec. 2. APPROPRIATION.**
