A bill for an act
relating to elections; authorizing an alternative method for casting in-person
absentee ballots; amending Minnesota Statutes 2014, section 203B.081.
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2014, section 203B.081, is amended to read:

**203B.081 LOCATIONS AND METHODS FOR ABSENTEE VOTING IN
PERSON.**

Subdivision 1. Location; timing. An eligible voter may vote by absentee ballot in
the office of the county auditor and at any other polling place designated by the county
auditor during the 46 days before the election, except as provided in this section.

Subd. 2. Town elections. Voters casting absentee ballots in person for a town
election held in March may do so during the 30 days before the election. The county
auditor shall make such designations at least 14 weeks before the election. At least one
voting booth in each polling place must be made available by the county auditor for
this purpose. The county auditor must also make available at least one electronic ballot
marker in each polling place that has implemented a voting system that is accessible for
individuals with disabilities pursuant to section 206.57, subdivision 5.

Subd. 3. Alternative procedure. (a) The county auditor may make available a
ballot counter and ballot box for use by the voters during the seven days before the
election. If a ballot counter and ballot box is provided, a voter must be given the option
either (1) to vote using the process provided in section 203B.08, subdivision 1, or (2) to
vote in the manner provided in this subdivision.

(b) If a voter chooses to vote in the manner provided in this subdivision, the voter
must state the voter's name, address, and date of birth to the county auditor or municipal

2.1 clerk. The voter shall sign a voter's certificate, which must include the voter's name,
2.2 identification number, and the certification required by section 201.071, subdivision 1.

2.3 The signature of an individual on the voter's certificate and the issuance of a ballot to the
2.4 individual is evidence of the intent of the individual to vote at that election.

2.5 (c) After signing the voter's certificate, the voter shall be issued a ballot and
2.6 immediately retire to a voting station or other designated location in the polling place to
2.7 mark the ballot. The ballot must not be taken from the polling place. If the voter spoils the
2.8 ballot, the voter may return it to the election official in exchange for a new ballot. After
2.9 completing the ballot, the voter shall deposit the ballot into the ballot box.

2.10 (d) The election official must immediately record that the voter has voted in the
2.11 manner provided in section 203B.121, subdivision 3.

2.12 (e) The election duties required by this subdivision must be performed by the county
2.13 auditor, municipal clerk, or a deputy of the auditor or clerk.
