Section 1. Minnesota Statutes 2006, section 16B.281, subdivision 3, is amended to read: 2.11 Subd. 3. Notice to agencies; determination of surplus. On or before October 1 of 2.12 each year, the commissioner shall review the certifications of heads of each department or 213 agency provided for in this section. The commissioner of administration shall send written 2.14 notice to all state departments, agencies, and the University of Minnesota describing any 2.15 lands or tracts that may be declared surplus.
