Section 1. Minnesota Statutes 2014, section 299A.41, subdivision 3, is amended to read:

- Subd. 3. **Killed in the line of duty.** "Killed in the line of duty" does not include deaths from natural causes, except as provided in this subdivision. In the case of a peace public safety officer, "killed in the line of duty" includes the death of an a public safety officer caused by accidental means while the peace public safety officer is acting in the course and scope of duties as a peace public safety officer. Killed in the line of duty also means if a public safety officer dies as the direct and proximate result of a heart attack or stroke, that officer shall be presumed to have died as the direct and proximate result of a personal injury sustained in the line of duty if:
 - (1) that officer, while on duty:

- (i) engaged in a situation, and that engagement involved nonroutine, stressful, or strenuous physical law enforcement, fire suppression, rescue, hazardous material response, emergency medical services, prison security, disaster relief, or other emergency response activity; or
- (ii) participated in a training exercise, and that participation involved nonroutine, stressful, or strenuous physical activity;
- (2) that officer died as a result of a heart attack or stroke suffered:
- (i) while engaging or participating under clause (1);
- (ii) while still on duty after engaging or participating under clause (1); or
