1.1 A bill for an act

1.2 relating to capital investment; appropriating money for clean water infrastructure  
1.3 improvements in Hibbing; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **CLEAN WATER INFRASTRUCTURE IMPROVEMENTS; HIBBING**  
1.6 **PUBLIC UTILITIES COMMISSION.**

1.7 Subdivision 1. **Appropriation.** \$4,500,000 is appropriated from the bond proceeds  
1.8 fund to the Public Utilities Commission for a grant to the Hibbing Public Utilities  
1.9 Commission to predesign, design, construct, furnish, and equip clean water infrastructure  
1.10 improvements in Hibbing. No nonstate match is required.

1.11 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the  
1.12 bond proceeds fund, the commissioner of management and budget shall sell and issue  
1.13 bonds of the state in an amount up to \$4,500,000 in the manner, upon the terms, and with  
1.14 the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the  
1.15 Minnesota Constitution, article XI, sections 4 to 7.

1.16 **EFFECTIVE DATE.** This section is effective the day following final enactment.
