BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. PILOT PROGRAM TO REDUCE TRAUMA FROM GUN VIOLENCE. 1.5 Subdivision 1. Pilot program. (a) The commissioner of health shall establish a pilot 1.6 program to aid in reducing trauma resulting from gun violence and to address the root causes 1.7 of gun violence. The pilot program shall consist of the following components: 1.8 (1) investing in community-based organizations that work with individuals at high risk 1.9 of experiencing gun violence or individuals experiencing trauma from gun violence to allow 1.10 the organizations to receive healing services and training on new, innovative practices or 1.11 evidence-based practices to address gun violence and trauma from gun violence; 1.12 (2) establishing and supporting the provision of stabilization services to families 1.13 experiencing trauma from gun violence by training community members to serve as trauma 1.14 navigators. Trauma navigators must be trained to use trauma-informed care and holistic 1.15 treatment modalities to provide support to families experiencing trauma from gun violence 1.16 and must help these families access resources needed for stabilization after gun violence 1.17 occurs, including but not limited to child care, housing, mental health and physical health 1.18 services, economic support, and education; 1.19 1.20 (3) supporting reintegration services to educate families about alternative ways to respond
