1.6	Section 1. [123B.051] CONTRACT DEADLINE AND PENALTY.
1.7	Subdivision 1. Definitions. For the purposes of this section, the following terms have
1.8	the meanings given them.
1.9	(a) "Public employer" means:
1.10	(1) a district; and
1.11	(2) a public employer, as defined in section 179A.03, subdivision 15, other than a distric

1.13	(i) negotiates a contract under chapter 179A with teachers; and
1.14	(ii) is established by, receives state money, or levies under chapters 120A to 129C, or
1.15	136D, or 268A.
1.16	(b) "Teacher" means a person, other than a superintendent, assistant superintendent,

1.18	position for which the person must be licensed by the Professional Educator Licensing and

2.2	year. If a collective bargaining agreement is not signed by that date, state aid paid to the
2.3	public employer for that fiscal year must be reduced. State aid must not be reduced if:
2.4	(1) a public employer and the exclusive representative of the teachers have submitted
2.5	all unresolved contract items to interest arbitration according to section 179A.16 before
2.6	December 31 of an odd-numbered year and filed required final positions on all unresolved
2.7	items with the commissioner of mediation services before January 15 of an even-numbered
2.8	year; and
2.9	(2) the arbitration panel has issued its decision within 60 days after the date the final
2.10	positions were filed.
2.11	Subd. 3. State aid penalty exemptions. (a) For a district that reorganizes according to
2.12	sections 123A.35 to 123A.43, 123A.46, or 123A.48, effective July 1 of an odd-numbered
2.13	year, state aid must not be reduced according to this section if the board and the exclusive
2.14	representative of the teachers both sign a collective bargaining agreement on or before the
2.15	March 15 following the effective date of reorganization.
2.16	(b) For a district that jointly negotiates a contract before the effective date of
2.17	reorganization under sections 123A.35 to 123A.43, 123A.46, or 123A.48, that for the first
2.18	time includes teachers in all districts to be reorganized, state aid must not be reduced

2.28	employer during the preceding fiscal year.
