relating to health occupations; creating an audiology and speech-language pathology interstate compact; authorizing the commissioner of health to release certain data; amending Minnesota Statutes 2020, section 144.051, subdivision 6; proposing coding for new law in Minnesota Statutes, chapter 148.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2020, section 144.051, subdivision 6, is amended to read:

Subd. 6. **Release of private or confidential data.** For providers regulated pursuant to sections 144A.43 to 144A.482, 148.5185, and chapter 144G, the department may release private or confidential data, except Social Security numbers, to the appropriate state, federal, or local agency and law enforcement office to enhance investigative or enforcement efforts or further a public health protective process. Types of offices include Adult Protective Services, Office of the Ombudsman for Long-Term Care and Office of the Ombudsman for Mental Health and Developmental Disabilities, the health licensing boards, Department of Human Services, county or city attorney's offices, police, and local or county public health offices.

# Sec. 2. [148.5185] AUDIOLOGY AND SPEECH-LANGUAGE PATHOLOGY INTERSTATE COMPACT.

# Section 1. Definitions

1.20 <u>As used in this Compact, and except as otherwise provided, the following definitions</u>
1.21 shall apply:

2.1	A. "Active duty military" means full-time duty status in the active uniformed service of
2.2	the United States, including members of the National Guard and Reserve on active duty
2.3	orders pursuant to 10 U.S.C. sections 1209 and 1211.
2.4	B. "Adverse action" means any administrative, civil, equitable, or criminal action
2.5	permitted by a state's laws which is imposed by a licensing board or other authority against
2.6	an audiologist or speech-language pathologist, including actions against an individual's
2.7	license or privilege to practice such as revocation, suspension, probation, monitoring of the
2.8	licensee, or restriction on the licensee's practice.
2.9	C. "Alternative program" means a non-disciplinary monitoring process approved by an
2.10	audiology or speech-language pathology licensing board to address impaired practitioners.
2.11	D. "Audiologist" means an individual who is licensed by a state to practice audiology.
2.12	E. "Audiology" means the care and services provided by a licensed audiologist as set
2.13	forth in the member state's statutes and rules.
2.14	F. "Audiology and Speech-Language Pathology Compact Commission" or "Commission"
2.15	means the national administrative body whose membership consists of all states that have
2.16	enacted the Compact.
2.17	G. "Audiology and speech-language pathology licensing board," "audiology licensing
2.18	board," "speech-language pathology licensing board," or "licensing board" means the agency
2.19	of a state that is responsible for the licensing and regulation of audiologists or
2.20	speech-language pathologists or both.
2.21	H. "Compact privilege" means the authorization granted by a remote state to allow a
2.22	licensee from another member state to practice as an audiologist or speech-language
2.23	pathologist in the remote state under its laws and rules. The practice of audiology or
2.24	speech-language pathology occurs in the member state where the patient, client, or student
2.25	is located at the time of the patient, client, or student encounter.
2.26	I. "Current significant investigative information" means investigative information that
2.27	a licensing board, after an inquiry or investigation that includes notification and an
2.28	opportunity for the audiologist or speech-language pathologist to respond, if required by
2.29	state law, has reason to believe is not groundless and, if proved true, would indicate more
2.30	than a minor infraction.
2.31	J. "Data system" means a repository of information about licensees, including, but not
2.32	limited to, continuing education, examination, licensure, investigation, compact privilege,
	and adverse action.

K. "Encumbered license" means a license in which an adverse action restricts the practic	ce
of audiology or speech-language pathology by the licensee and said adverse action has been	en
reported to the National Practitioners Data Bank (NPDB).	
L. "Executive Committee" means a group of directors elected or appointed to act on	
behalf of, and within the powers granted to them by, the Commission.	
M. "Home state" means the member state that is the licensee's primary state of residence	ce.
N. "Impaired practitioner" means individuals whose professional practice is adversely	ly
affected by substance abuse, addiction, or other health-related conditions.	
O. "Licensee" means an individual who currently holds an authorization from the sta	ite
licensing board to practice as an audiologist or speech-language pathologist.	
P. "Member state" means a state that has enacted the Compact.	
Q. "Privilege to practice" means a legal authorization permitting the practice of audiolog	gy
or speech-language pathology in a remote state.	
R. "Remote state" means a member state other than the home state where a licensee is	<u>is</u>
exercising or seeking to exercise the compact privilege.	
S. "Rule" means a regulation, principle, or directive promulgated by the Commission	n
that has the force of law.	
T. "Single-state license" means an audiology or speech-language pathology license	
issued by a member state that authorizes practice only within the issuing state and does n	ot
include a privilege to practice in any other member state.	
U. "Speech-language pathologist" means an individual who is licensed by a state to	
practice speech-language pathology.	
V. "Speech-language pathology" means the care and services provided by a licensed	
speech-language pathologist as set forth in the member state's statutes and rules.	
W. "State" means any state, commonwealth, district, or territory of the United States	of
America that regulates the practice of audiology and speech-language pathology.	
X. "State practice laws" means a member state's laws, rules, and regulations that gover	rn
the practice of audiology or speech-language pathology, define the scope of audiology or	r
speech-language pathology practice, and create the methods and grounds for imposing	
discipline.	

Y. "Telehealth" means the application of telecommunication technology to deliver 4.1 audiology or speech-language pathology services at a distance for assessment, intervention, 4.2 4.3 or consultation. Section 2. State Participation in the Compact 4.4 4.5 A. A license issued to an audiologist or speech-language pathologist by a home state to a resident in that state shall be recognized by each member state as authorizing an audiologist 4.6 or speech-language pathologist to practice audiology or speech-language pathology, under 4.7 a privilege to practice, in each member state. 4.8 B. A state must implement or utilize procedures for considering the criminal history 4.9 records of applicants for initial privilege to practice. 6.10	6. Has not been convicted or found guilty, and has not entered into an agreed disposition,
6.11	of a felony related to the practice of speech-language pathology, under applicable state or
6.12	federal criminal law; and
6.13	7. Has a valid United States Social Security or National Practitioner Identification
6.14	number.
6.15	G. The privilege to practice is derived from the home state license.
6.16	H. An audiologist or speech-language pathologist practicing in a member state must
6.17	comply with the state practice laws of the state in which the client is located at the time
6.18	service is provided. The practice of audiology and speech-language pathology shall include
6.19	all audiology and speech-language pathology practice as defined by the state practice laws
6.20	of the member state in which the client is located. The practice of audiology and
6.21	speech-language pathology in a member state under a privilege to practice shall subject an
6.22	audiologist or speech-language pathologist to the jurisdiction of the licensing board, the
6.23	courts and the laws of the member state in which the client is located at the time service is
6.24	provided.
6.25	I. Individuals not residing in a member state shall continue to be able to apply for a
6.26	member state's single-state license as provided under the laws of each member state.
6.27	However, the single-state license granted to these individuals shall not be recognized as
6.28	granting the privilege to practice audiology or speech-language pathology in any other
6.29	member state. Nothing in this Compact shall affect the requirements established by a member
6.30	state for the issuance of a single-state license.

J. Member states may charge a fee for granting a compact privilege.

K. Member states must comply with the bylaws and rules and regulations of the 7.1 Commission. 7.2 Section 3. Compact Privilege 7.3 A. To exercise the compact privilege under the terms and provisions of the Compact, 7.4 7.5 the audiologist or speech-language pathologist shall: 1. Hold an active license in the home state; 7.6 7.7 2. Have no encumbrance on any state license; 3. Be eligible for a compact privilege in any member state in accordance with Section 7.8 2; 7.9 4. Have not had any adverse action against any license or compact privilege within the 7.10 previous two years from date of application; 7.11 5. Notify the Commission that the licensee is seeking the compact privilege within a 7.12 remote state(s); 7.13 6. Pay any applicable fees, including any state fee, for the compact privilege; and 7.14 7. Report to the Commission adverse action taken by any non-member state within 30 7.15 days from the date the adverse action is taken. 7.16 7.17 B. For the purposes of the compact privilege, an audiologist or speech-language pathologist shall only hold one home state license at a time. 7.18 C. Except as provided in Section 5, if an audiologist or speech-language pathologist 7.19 changes primary state of residence by moving between two member states, the audiologist 7.20 or speech-language pathologist must apply for licensure in the new home state, and the 7.21 license issued by the prior home state shall be deactivated in accordance with applicable 7.22 rules adopted by the Commission. 7.23 D. The audiologist or speech-language pathologist may apply for licensure in advance 7.24 of a change in primary state of residence. 7.25 E. A license shall not be issued by the new home state until the audiologist or 7.26 speech-language pathologist provides satisfactory evidence of a change in primary state of 7.27 residence to the new home state and satisfies all applicable requirements to obtain a license 7.28 from the new home state. 7.29

8.1	F. If an audiologist or speech-language pathologist changes primary state of residence
8.2	by moving from a member state to a non-member state, the license issued by the prior home
8.3	state shall convert to a single-state license, valid only in the former home state.
8.4	G. The compact privilege is valid until the expiration date of the home state license. The
8.5	licensee must comply with the requirements of Section 3A to maintain the compact privilege
8.6	in the remote state.
8.7	H. A licensee providing audiology or speech-language pathology services in a remote
8.8	state under the compact privilege shall function within the laws and regulations of the remote
8.9	state.
8.10	I. A licensee providing audiology or speech-language pathology services in a remote
8.11	state is subject to that state's regulatory authority. A remote state may, in accordance with
8.12	due process and that state's laws, remove a licensee's compact privilege in the remote state
8.13	for a specific period of time, impose fines, or take any other necessary actions to protect
8.14	the health and safety of its citizens.
8.15	J. If a home state license is encumbered, the licensee shall lose the compact privilege in
8.16	any remote state until the following occur:
8.17	1. The home state license is no longer encumbered; and
8.18	2. Two years have elapsed from the date of the adverse action.
8.19	K. Once an encumbered license in the home state is restored to good standing, the licensee
8.20	must meet the requirements of Section 3A to obtain a compact privilege in any remote state.
8.21	L. Once the requirements of Section 3J have been met, the licensee must meet the
8.22	requirements in Section 3A to obtain a compact privilege in a remote state.
8.23	Section 4. Compact Privilege to Practice Telehealth
8.24	Member states shall recognize the right of an audiologist or speech-language pathologist
8.25	licensed by a home state in accordance with Section 2 and under rules promulgated by the
8.26	Commission, to practice audiology or speech-language pathology in a member state via
8.27	telehealth under a privilege to practice as provided in the Compact and rules promulgated
8.28	by the Commission.
8.29	Section 5. Active Duty Military Personnel or Their Spouses
8.30	Active duty military personnel, or their spouse, shall designate a home state where the
8.31	individual has a current license in good standing. The individual may retain the home state
8.32	designation during the period the service member is on active duty. Subsequent to designating

a home state, the individual shall only change their home state through application for licensure in the new state.

### Section 6. Adverse Actions

- A. In addition to the other powers conferred by state law, a remote state shall have the authority, in accordance with existing state due process law, to:
- 1. Take adverse action against an audiologist's or speech-language pathologist's privilege to practice within that member state.
- 2. Issue subpoenas for both hearings and investigations that require the attendance and testimony of witnesses as well as the production of evidence. Subpoenas issued by a licensing board in a member state for the attendance and testimony of witnesses or the production of evidence from another member state shall be enforced in the latter state by any court of competent jurisdiction, according to the practice and procedure of that court applicable to subpoenas issued in proceedings pending before it. The issuing authority shall pay any witness fees, travel expenses, mileage and other fees required by the service statutes of the state in which the witnesses or evidence are located.
- B. Only the home state shall have the power to take adverse action against an audiologist's or speech-language pathologist's license issued by the home state.
- C. For purposes of taking adverse action, the home state shall give the same priority and effect to reported conduct received from a member state as it would if the conduct had occurred within the home state. In so doing, the home state shall apply its own state laws to determine appropriate action.
- D. The home state shall complete any pending investigations of an audiologist or speech-language pathologist who changes primary state of residence during the course of the investigations. The home state shall also have the authority to take appropriate action(s) and shall promptly report the conclusions of the investigations to the administrator of the data system. The administrator of the data system shall promptly notify the new home state of any adverse actions.
- E. If otherwise permitted by state law, the member state may recover from the affected audiologist or speech-language pathologist the costs of investigations and disposition of cases resulting from any adverse action taken against that audiologist or speech-language pathologist.
- F. The member state may take adverse action based on the factual findings of the remote state, provided that the home state follows its own procedures for taking the adverse action.

10.1	G. Joint Investigations
10.2	1. In addition to the authority granted to a member state by its respective audiology or
10.3	speech-language pathology practice act or other applicable state law, any member state may
10.4	participate with other member states in joint investigations of licensees.
10.5	2. Member states shall share any investigative, litigation, or compliance materials in
10.6	furtherance of any joint or individual investigation initiated under the Compact.
10.7	H. If adverse action is taken by the home state against an audiologist's or speech-language
10.8	pathologist's license, the audiologist's or speech-language pathologist's privilege to practice
10.9	in all other member states shall be deactivated until all encumbrances have been removed
10.10	from the state license. All home state disciplinary orders that impose adverse action against
10.11	an audiologist's or speech-language pathologist's license shall include a statement that the
10.12	audiologist's or speech-language pathologist's privilege to practice is deactivated in all
10.13	member states during the pendency of the order.
10.14	I. If a member state takes adverse action, it shall promptly notify the administrator of
10.15	the data system. The administrator of the data system shall promptly notify the home state
10.16	of any adverse actions by remote states.
10.17	J. Nothing in this Compact shall override a member state's decision that participation in
10.18	an alternative program may be used in lieu of adverse action.
10.19	Section 7. Establishment of the Audiology and Speech-Language Pathology Compact
10.20	Commission
10.21	A. The Compact member states hereby create and establish a joint public agency known
10.22	as the Audiology and Speech-Language Pathology Compact Commission:
10.23	1. The Commission is an instrumentality of the Compact states.

- 2. Venue is proper and judicial proceedings by or against the Commission shall be brought solely and exclusively in a court of competent jurisdiction where the principal office of the Commission is located. The Commission may waive venue and jurisdictional defenses to the extent it adopts or consents to participate in alternative dispute resolution proceedings.
- 3. Nothing in this Compact shall be construed to be a waiver of sovereign immunity. 10.28
- 10.29 B. Membership, Voting, and Meetings

1. Each member state shall have two delegates selected by that member state's licensing 10.30 10.31 board. The delegates shall be current members of the licensing board. One shall be an 10.32 audiologist and one shall be a speech-language pathologist.

11.1	2. An additional five delegates, who are either a public member or board administrator
11.2	from a state licensing board, shall be chosen by the Executive Committee from a pool of
11.3	nominees provided by the Commission at Large.
11.4	3. Any delegate may be removed or suspended from office as provided by the law of
11.5	the state from which the delegate is appointed.
11.6	4. The member state board shall fill any vacancy occurring on the Commission, within
11.7	90 days.
11.8	5. Each delegate shall be entitled to one vote with regard to the promulgation of rules

11.11	6. A delegate shall vote in person or by other means as provided in the bylaws. The
11.12	bylaws may provide for delegates' participation in meetings by telephone or other means
11.13	of communication.
11.14	7. The Commission shall meet at least once during each calendar year. Additional
11.15	meetings shall be held as set forth in the bylaws.
11.16	C. The Commission shall have the following powers and duties:
11.17	1. Establish the fiscal year of the Commission;
11.18	2. Establish bylaws;
11.19	3. Establish a Code of Ethics;
11.20	4. Maintain its financial records in accordance with the bylaws;
11.21	5. Meet and take actions as are consistent with the provisions of this Compact and the
11.22	bylaws;
11.23	6. Promulgate uniform rules to facilitate and coordinate implementation and
11.24	administration of this Compact. The rules shall have the force and effect of law and shall
11.25	be binding in all member states;
11.26	7. Bring and prosecute legal proceedings or actions in the name of the Commission,
11.27	provided that the standing of any state audiology or speech-language pathology licensing
11.28	board to sue or be sued under applicable law shall not be affected;
11.29	8. Purchase and maintain insurance and bonds;
11.30	9. Borrow, accept, or contract for services of personnel, including, but not limited to,
11.31	employees of a member state;

12.1	10. Hire employees, elect or appoint officers, fix compensation, define duties, grant
12.2	individuals appropriate authority to carry out the purposes of the Compact, and establish
12.3	the Commission's personnel policies and programs relating to conflicts of interest,
12.4	qualifications of personnel, and other related personnel matters;
12.5	11. Accept any and all appropriate donations and grants of money, equipment, supplies,
12.6	materials and services, and to receive, utilize and dispose of the same; provided that at all
12.7	times the Commission shall avoid any appearance of impropriety and/or conflict of interest;
12.8	12. Lease, purchase, accept appropriate gifts or donations of, or otherwise own, hold,
12.9	improve or use, any property, real, personal, or mixed; provided that at all times the
12.10	Commission shall avoid any appearance of impropriety;
12.11	13. Sell, convey, mortgage, pledge, lease, exchange, abandon, or otherwise dispose of
12.12	any property real, personal, or mixed;
12.13	14. Establish a budget and make expenditures;
12.14	15. Borrow money;
12.15	16. Appoint committees, including standing committees composed of members, and
12.16	other interested persons as may be designated in this Compact and the bylaws;
12.17	17. Provide and receive information from, and cooperate with, law enforcement agencies;
12.18	18. Establish and elect an Executive Committee; and
12.19	19. Perform other functions as may be necessary or appropriate to achieve the purposes
12.20	of this Compact consistent with the state regulation of audiology and speech-language
12.21	pathology licensure and practice.
12.22	D. The Executive Committee
12.23	The Executive Committee shall have the power to act on behalf of the Commission
12.24	according to the terms of this Compact.
12.25	1. The Executive Committee shall be composed of ten members:
12.26	a. Seven voting members who are elected by the Commission from the current
12.27	membership of the Commission;
12.28	b. Two ex-officios, consisting of one nonvoting member from a recognized national
12.29	audiology professional association and one nonvoting member from a recognized national
12.30	speech-language pathology association; and

E. The ex-officio members shall be selected by their respective organiza	ations.

- 13.4 1. The Commission may remove any member of the Executive Committee as provided
  13.5 in bylaws.
- 2. The Executive Committee shall meet at least annually.
- 3. The Executive Committee shall have the following duties and responsibilities:
- a. Recommend to the entire Commission changes to the rules or bylaws, changes to this
   Compact legislation, fees paid by Compact member states such as annual dues, and any
   commission Compact fee charged to licensees for the compact privilege;
- b. Ensure Compact administration services are appropriately provided, contractual or otherwise;
- c. Prepare and recommend the budget;

- d. Maintain financial records on behalf of the Commission;
- e. Monitor Compact compliance of member states and provide compliance reports to the Commission;
- f. Establish additional committees as necessary; and
- g. Other duties as provided in rules or bylaws.
- 4. Meetings of the Commission
- All meetings shall be open to the public, and public notice of meetings shall be given in the same manner as required under the rulemaking provisions in Section 9.
- 5. The Commission or the Executive Committee or other committees of the Commission
  may convene in a closed, non-public meeting if the Commission or Executive Committee
  or other committees of the Commission must discuss:
- a. Non-compliance of a member state with its obligations under the Compact;
- b. The employment, compensation, discipline, or other matters, practices, or procedures
  related to specific employees or other matters related to the Commission's internal personnel
  practices and procedures;
- c. Current, threatened, or reasonably anticipated litigation;

9. The Commission shall not incur obligations of any kind prior to securing the funds adequate to meet the same; nor shall the Commission pledge the credit of any of the member states, except by and with the authority of the member state.

10. The Commission shall keep accurate accounts of all receipts and disbursements. The receipts and disbursements of the Commission shall be subject to the audit and accounting procedures established under its bylaws. However, all receipts and disbursements of funds handled by the Commission shall be audited yearly by a certified or licensed public accountant, and the report of the audit shall be included in and become part of the annual report of the Commission.

## F. Qualified Immunity, Defense, and Indemnification

- 1. The members, officers, executive director, employees and representatives of the Commission shall be immune from suit and liability, either personally or in their official capacity, for any claim for damage to or loss of property or personal injury or other civil liability caused by or arising out of any actual or alleged act, error, or omission that occurred, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities; provided that nothing in this paragraph shall be construed to protect any person from suit or liability for any damage, loss, injury, or liability caused by the intentional or willful or wanton misconduct of that person.
- 2. The Commission shall defend any member, officer, executive director, employee, or representative of the Commission in any civil action seeking to impose liability arising out of any actual or alleged act, error, or omission that occurred within the scope of Commission employment, duties, or responsibilities, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities; provided that nothing herein shall be construed to prohibit that person from retaining his or her own counsel; and provided further, that the actual or alleged act, error, or omission did not result from that person's intentional or willful or wanton misconduct.
- 3. The Commission shall indemnify and hold harmless any member, officer, executive director, employee, or representative of the Commission for the amount of any settlement or judgment obtained against that person arising out of any actual or alleged act, error or omission that occurred within the scope of Commission employment, duties, or responsibilities, or that person had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities, provided that the actual or alleged

The revision may be challenged only on grounds that the revision results in a material change to a rule. A challenge shall be made in writing and delivered to the chair of the Commission prior to the end of the notice period. If no challenge is made, the revision shall take effect without further action. If the revision is challenged, the revision may not take effect without the approval of the Commission. Section 10. Oversight, Dispute Resolution, and Enforcement A. Dispute Resolution 1. Upon request by a member state, the Commission shall attempt to resolve disputes related to the Compact that arise among member states and between member and non-member states. 2. The Commission shall promulgate a rule providing for both mediation and binding dispute resolution for disputes as appropriate. B. Enforcement 1. The Commission, in the reasonable exercise of its discretion, shall enforce the provisions and rules of this Compact. 2. By majority vote, the Commission may initiate legal action in the United States District Court for the District of Columbia or the federal district where the Commission has its principal offices against a member state in default to enforce compliance with the provisions of the Compact and its promulgated rules and bylaws. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing member shall be awarded all costs of litigation, including reasonable attorney's fees. 3. The remedies herein shall not be the exclusive remedies of the Commission. The Commission may pursue any other remedies available under federal or state law. Section 11. Date of Implementation of the Interstate Commission for Audiology and Speech-Language Pathology Practice and Associated Rules, Withdrawal, and Amendment A. The Compact shall come into effect on the date on which the Compact statute is enacted into law in the tenth member state. The provisions, which become effective at that time, shall be limited to the powers granted to the Commission relating to assembly and the promulgation of rules. Thereafter, the Commission shall meet and exercise rulemaking powers necessary to the implementation and administration of the Compact.
