1.3 land and buildings and other improvements of a capital nature with certain

1.4 conditions; modifying previous appropriations; establishing new programs and

1.16 style="text-align:center">**APPROPRIATIONS**

1.17 Section 1. **CAPITAL IMPROVEMENT APPROPRIATIONS.**

1.18 The sums shown in the column under "Appropriations" are appropriated from the bond

1.19 proceeds fund, or another named fund, to the state agencies or officials indicated, to be

1.20 spent for public purposes. Appropriations of bond proceeds must be spent as authorized by

1.21 the Minnesota Constitution, article XI, section 5, clause (a), to acquire and better public

1.22 land and buildings and other public improvements of a capital nature, or as authorized by

1.23 the Minnesota Constitution, article XI, section 5, clauses (b) to (j), or article XIV. Unless

1.24 otherwise specified, money appropriated in this act:

1.25 (1) may be used to pay state agency staff costs that are attributed directly to the capital

1.26 program or project in accordance with accounting policies adopted by the commissioner of

1.27 management and budget;

2.1 (2) is available until the project is completed or abandoned subject to Minnesota Statutes,
 2.2 section 16A.642;

2.3 (3) for activities under Minnesota Statutes, sections 16B.307, 84.946, and 135A.046,
 2.4 should not be used for projects that can be financed within a reasonable time frame under
 2.5 Minnesota Statutes, section 16B.322 or 16C.144; and

2.6 (4) is available for a grant to a political subdivision after the commissioner of management
 2.7 and budget determines that an amount sufficient to complete the project as described in this
 2.8 act has been committed to the project, as required by Minnesota Statutes, section 16A.502.

2.11 **Subdivision 1. Total Appropriation** **\$ 85,000,000**

2.12 To the Board of Regents of the University of
 2.13 Minnesota for the purposes specified in this
 2.14 section.

2.15 **Subd. 2. Higher Education Asset Preservation**
 2.16 **and Replacement (HEAPR)** **55,800,000**

2.17 To be spent in accordance with Minnesota
 2.18 Statutes, section 135A.046.

2.19 **Subd. 3. Twin Cities - Child Development**
 2.20 **Building Replacement** **29,200,000**

2.21 To predesign, design, renovate, expand,
 2.22 furnish, and equip the Institute of Child
 2.23 Development building on the Twin Cities
 2.24 campus. This project includes the demolition
 2.25 and replacement of the 1968 building addition.

2.26 **Subd. 4. University Share**

2.27 Except for the appropriations for HEAPR, the
 2.28 appropriations in this section are intended to
 2.29 cover approximately two-thirds of the cost of
 2.30 each project. The remaining costs must be paid
 2.31 from university sources.

2.32 **Subd. 5. Unspent Appropriations**

3.1 Upon substantial completion of a project
 3.2 authorized in this section and after written
 3.3 notice to the commissioner of management
 3.4 and budget, the Board of Regents must use
 3.5 any money remaining in the appropriation for
 3.6 that project for HEAPR under Minnesota
 3.7 Statutes, section 135A.046. The Board of
 3.8 Regents must report by February 1 of each
 3.9 even-numbered year to the chairs of the house
 3.10 of representatives and senate committees with
 3.11 jurisdiction over capital investment and higher

4.15 **Subd. 2. Natural Resources Asset Preservation** **19,000,000**

4.16 For the renovation of state-owned facilities

9.23 To acquire land or permanent easements and
 9.24 to restore, create, enhance, and preserve
 9.25 wetlands to replace those wetlands drained or
 9.26 filled as a result of the repair, reconstruction,
 9.27 replacement, or rehabilitation of existing
 9.28 public roads as required by Minnesota
 9.29 Statutes, section 103G.222, subdivision 1,
 9.30 paragraphs (l) and (m). The board may vary
 9.31 the priority order of Minnesota Statutes,
