1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. SURROGACY TASK FORCE.
1.7	Subdivision 1. Membership. (a) The Surrogacy Task Force for the study
1.8	of gestational and traditional surrogacy consists of 24 members, appointed by the
1.9	commissioner of human services except where otherwise specified, as follows:
1.10	(1) the commissioner of human services or a person designated by the commissioner
1.11	of human services;
1.12	(2) the commissioner of health or a person designated by the commissioner of health;
1.13	(3) two members of the house of representatives, one appointed by the speaker of the
1.14	house and one appointed by the minority leader;
1.15	(4) two senators appointed by the Subcommittee on Committees of the Committee
1.16	on Rules and Administration, one from the majority party and one from the minority party;
1.17	(5) one person designated by the chair of the Family Law section and one person

2.33	technical assistance within available resources.
2.34	Subd. 6. Duties; report; expiration. The Surrogacy Task Force shall review and
2.35	study the legal issues implicated by the practice of gestational and traditional surrogacy
2.36	in the state of Minnesota and make recommendations to the legislature on legal issues

3.1	related to surrogacy. The Surrogacy Task Force must report its findings and make
3.2	recommendations to address legal issues implicated by surrogacy to the chairs and ranking
3.3	minority members of the legislative committees in the house of representatives and the
3.4	senate with primary jurisdiction over health and judiciary by January 15, 2017. The report
3.5	must include draft legislation to implement the recommendations of the task force. The
3.6	task force expires on submission of the report required by this subdivision or on January
3.7	16, 2017, whichever is earlier.

EFFECTIVE DATE. This section is effective the day following final enactment.
