BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. UNIVERSAL ACCESS TO PRE-EXPOSURE PROPHYLAXIS (PREP) 1.5 AND POST-EXPOSURE PROPHYLAXIS (PEP) PROGRAM. 1.6 Subdivision 1. General. The commissioner of health shall implement a health initiative 1.7 to provide universal access to PrEP medicines to prevent HIV infection and PEP antiretroviral 1.8 medicines to address potential exposure to HIV. The purpose of the program is to provide 19 access to those persons who are not insured, persons whose insurance does not cover PrEP 1.10 and PEP medicines, or persons who have co-pay charges that make access to the medicines 1.11 unaffordable. The goal of the program is to improve health outcomes and reduce health care 1.12 costs by managing care to prevent HIV. 1.13 Subd. 2. **Funding.** The commissioner shall seek funding for the program through an 1.14 appropriation from AIDS Drug Assistance Program (ADAP) and the pharmaceutical rebate 1.15 revenue program.
