authorizes sales on all days of the week to persons attending events at the convention
center. This paragraph does not apply to convention centers located in the seven-county
metropolitan area.

(d) A city may issue an on-sale wine license and an on-sale malt liquor license to 2.9 a person who is the owner of a summer collegiate league baseball team, or to a person 2.10 holding a concessions or management contract with the owner, for beverage sales at a 2.11 ballpark or stadium located within the city for the purposes of summer collegiate league 2.12 baseball games at the ballpark or stadium, notwithstanding any law, local ordinance, or 2.13 charter provision. A license issued under this paragraph authorizes sales on all days of the 2.14 2.15 week to persons attending baseball games at the ballpark or stadium. (e) A city may issue an on-sale wine license and an on-sale malt liquor license to 2.16 a person who is the operator of a business not related to the service of alcohol, for the 2.17 purpose of serving wine or malt liquor as an amenity that is complimentary to the person's 2.18 business, notwithstanding any law, local ordinance, or charter provision.
