1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Laws 2019, First Special Session chapter 9, article 4, section 28, is amended

1.10 (a) The commissioner of human services shall develop incentive-based grants to be

1.11 ~~available during fiscal years 2020 and 2021 only for elderly waiver providers of customized~~

1.12 ~~living service providers~~ services under the brain injury, community access for disability

1.13 inclusion, and elderly waivers for achieving outcomes specified in a contract. The

1.14 commissioner may solicit proposals from providers and implement those that, on a

1.15 competitive basis, best meet the state's policy objectives, giving preference to providers that

1.16 serve at least 75 percent elderly waiver participants or at least 25 percent brain injury or

1.17 community access for disability inclusion waiver participants. The commissioner shall limit

1.18 expenditures under this subdivision to the amount appropriated for this purpose.

1.19 (b) In establishing the specified outcomes and related criteria, the commissioner shall

1.20 consider the following state policy objectives:

1.21 (1) provide more efficient, higher quality services;

1.22 (2) encourage home and community-based services providers to innovate;

2.1 (3) equip home and community-based services providers with organizational tools and
2.2 expertise to improve their quality;

2.3 (4) incentivize home and community-based services providers to invest in better services;

2.5 (5) disseminate successful performance improvement strategies statewide.
