- 1.8 Subd. 2e. **Local optional revenue.** (a) ~~For fiscal year 2021 and later,~~ Local optional
- 1.9 revenue for a school district equals the sum of the district's first tier local optional revenue
- 1.10 and second tier local optional revenue. A district's first tier local optional revenue equals
- 1.11 \$300 times the adjusted pupil units of the district for that school year. A district's second
- 1.12 tier local optional revenue equals \$424 times the adjusted pupil units of the district for that
- 1.13 school year.
- 1.14 (b) ~~For fiscal year 2021 and later,~~ A district's local optional levy equals the sum of the
- 1.15 first tier local optional levy and the second tier local optional levy.

2.4 (e) The local optional levy must be spread on referendum market value. A district may
2.5 levy less than the permitted amount.

2.6 (f) A district's local optional aid equals its local optional revenue minus its local optional
2.7 levy. If a district's actual levy for first or second tier local optional revenue is less than its
2.8 maximum levy limit for that tier, its aid must be proportionately reduced.

2.9 **EFFECTIVE DATE.** This section is effective for revenue for fiscal year 2024 and later.
