(a) Upon the dismissal and discharge of 1.9 criminal proceedings brought against a person as a result of mistaken identity or another 1.10 person using the identifying information of the named person by identity theft under section 1.11 609.527, the prosecutor shall notify the court of the dismissal and discharge under section 1.12 609A.025.
