1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. REPORT ON RECREATIONAL USE OF PERMANENT SCHOOL
1.7	LANDS.
1.8	Subdivision 1. Office of School Trust Lands. The school trust lands director shall
1.9	conduct a study of the recreational use of school trust lands in the state. The study shall be
1.10	used to determine the amount of money to be allocated to the permanent school fund for
1.11	fees paid to the state for outdoor recreation purposes. The Department of Natural Resources
1.12	must assist the office by providing existing outdoor recreation use data. The office may
1.13	contract for additional survey data to complete the study. The study shall include the
1.14	following:
1.15	(1) the estimated annual number of daily visits by individuals with a Minnesota hunting
1.16	license accessing school trust lands, and as a percentage of annual days hunted by all
1.17	individuals with a Minnesota hunting license;
1.18	(2) the estimated annual number of daily visits by individuals with a Minnesota fishing
1.19	license using a public water access site that contains school trust lands, and as a percentage
1.20	of annual days fishing by all individuals with a Minnesota fishing license;
1.21	(3) the estimated annual visits by Minnesota licensed watercrafts to state-owned public
1.22	water access sites that contain school trust lands, and as a percentage of all visits by
1.23	Minnesota licensed watercrafts using public water access sites;

2.1	(4) the total number of miles of state-maintained snowmobile trails and all-terrain vehicle
2.2	trails that are on school trust lands, and as a percentage of total miles of state-operated trails

2.5	areas, and as a percentage of all acres of land in state parks and recreation areas;

2.18	Subd. 3. Appropriation. \$ in fiscal year 2025 is appropriated from the fund to
