(a) The commissioner of human services 17 shall establish a dental home pilot project to increase access of medical assistance and 1.8 MinnesotaCare enrollees to dental care, improve patient experience, and improve oral health 1.9 clinical outcomes, in a manner that sustains the financial viability of the dental workforce 1.10 and broader dental care delivery and financing system. 2.6	(6) the extent to which pilot project requirements may vary with provider characteristics;
2.7	(7) procedures for data collection;
2.8	(8) the role of dental partners, such as dental professional organizations and educational
2.9	institutions;
2.10	(9) provider support and education; and
2.11	(10) other topics identified by the commissioner.
2.12	(b) The commissioner shall consider the feedback and input obtained in paragraph (a)
2.13	and shall develop and issue a request for proposals for participation in the pilot project.
2.14	(c) The pilot project must be implemented by July 1, 2023, and must include initial pilot
2.15	testing and the collection and analysis of data on baseline requirements and performance
2.16	measures to evaluate whether these requirements and measures are appropriate. Under this
2.17	phase, the commissioner shall provide grants to individual providers and provider networks
2.18	in addition to medical assistance and MinnesotaCare payments received for services provided.

2.26	(f) In designing and implementing the pilot project, the commissioner shall regularly
2.27	consult with project participants and other stakeholders, and as relevant shall continue to
2.28	seek the input of participants and other stakeholders on the topics listed in paragraph (a).
2.29	Subd. 3. Reporting. (a) The commissioner, beginning February 15, 2023, and each
2.30	February 15 thereafter for the duration of the demonstration project, shall report on the

and ranking minority members of the legislative committees with jurisdiction over health care finance and policy.

(b) The commissioner, within six months from the date the pilot project ceases operation, shall report to the chairs and ranking minority members of the legislative committees with jurisdiction over health care finance and policy on the results of the demonstration project, and shall include in the report recommendations on whether the demonstration project, or specific features of the demonstration project, should be extended to all dental providers serving medical assistance and MinnesotaCare enrollees.
