- 1.8 Section 1. Minnesota Statutes 2023 Supplement, section 352.91, subdivision 3f, is amended

- 1.10 Subd. 3f. **Additional Department of Human Services personnel.** (a) "Covered
- 1.11 correctional service" means service by a state employee in one of the employment positions
- 1.12 specified in paragraph (b) in the state-operated forensic services program or the Minnesota
- 1.13 Sex Offender Program if at least 75 percent of the employee's working time is spent in direct
- 1.14 contact with patients and the determination of this direct contact is certified to the executive
- 1.15 director by the commissioner of human services.

3.10 **EFFECTIVE DATE.** This section is effective on the first day of the first payroll period
3.11 occurring after the day of enactment.

3.12 Sec. 2. **NEW POSITIONS PERMITTED TO TRANSFER PAST SERVICE CREDIT**
3.13 **FROM THE MSRS GENERAL PLAN.**

3.14 For each employee whose employment position is baker, cook, culinary supervisor, or
3.15 kitchen supervisor and who enters the correctional state employees retirement plan on the
3.16 effective date of section 1, the executive director must consider the employee an eligible
3.17 employee under Minnesota Statutes, section 352.955, subdivision 1, paragraph (b), for
3.18 purposes of Minnesota Statutes, section 352.955. The executive director must transfer, from
3.19 the general state employees retirement plan to the correctional state employees retirement
3.20 plan, any eligible prior correctional employment as defined under Minnesota Statutes,
3.21 section 352.955, subdivision 1, paragraph (c), if elected by the eligible employee, subject
3.22 to all other requirements of Minnesota Statutes, section 352.955, including payment by the
3.23 eligible employee of the additional member contribution as defined under Minnesota Statutes,
3.24 section 352.955, subdivision 3, paragraph (a).

3.25 **EFFECTIVE DATE.** This section is effective the day following final enactment.
