procedures and criteria in consultation	with representatives of the Minnesota Association
of Townships and the appropriate state	e agency as needed. The criteria for determining
project priority and the amount of a gr	ant or loan must be based on consideration of:
(1) the availability of other state, for	ederal, and local funds;
(2) the effectiveness of the propose	ed project in eliminating a transportation system
deficiency;	
(3) the number of people who will	be positively impacted by the project;
(4) the project's contribution to loc	al, regional, or state economic development or
