1.7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.8	Section 1. Minnesota Statutes 2022, section 171.01, is amended by adding a subdivision
1.9	to read:
1.10	Subd. 46a. Secondary mailing address. "Secondary mailing address" means the mailing
1.11	address of any place where a person regularly or occasionally stays and may receive mail
1.12	in their name other than the person's residence address. A secondary mailing address does
1.13	not include the designated address under section 5B.05.
1.14	EFFECTIVE DATE. This section is effective August 1, 2024.
1.15	Sec. 2. Minnesota Statutes 2023 Supplement, section 171.06, subdivision 3, is amended
1.16	to read:
1.17	Subd. 3. Contents of application; other information. (a) An application must:
1.18	(1) state the full name, date of birth, sex, and either (i) the residence address of the
1.19	applicant, (ii) a secondary mailing address under subdivision 3c, which may be indicated
1.20	in addition to the residence address or designated address, or (ii) (iii) a designated address
1.21	under section 5B.05;

2.22	(b) Applications must be accompanied by satisfactory evidence demonstrating:

2.26	(i) principal residence address in Minnesota, including application for a change of address,
2.27	unless the applicant provides a designated address under section 5B.05;

2.29	(iii) lawful status, as defined in Code of Federal Regulations, title 6, section 37.3.

3.1 (c) An application for an enhanced driver's license or enhanced identification card must
3.2 be accompanied by:

3.3 (1) satisfactory evidence demonstrating the applicant's full legal name and United States
3.4 citizenship; and

3.5 (2) a photographic identity document.

3.6 (d) A valid Department of Corrections or Federal Bureau of Prisons identification card
3.7 containing the applicant's full name, date of birth, and photograph issued to the applicant
3.8 is an acceptable form of proof of identity in an application for an identification card,
3.9 instruction permit, or driver's license as a secondary document for purposes of Minnesota
3.10 Rules, part 7410.0400, and successor rules.

(e) An application form must not provide for identification of (1) the accompanying
documents used by an applicant to demonstrate identity, or (2) except as provided in
paragraphs (b) and (c), the applicant's citizenship, immigration status, or lawful presence
in the United States. The commissioner and a driver's license agent must not inquire about
an applicant's citizenship, immigration status, or lawful presence in the United States, except
as provided in paragraphs (b) and (c).

3.17 EFFECTIVE DATE. This section is effective August 1, 2024, and applies to applications 3.18 made on or after that date.

The department may not issue an enhanced 6.1 identification card to an individual who is under 16 years of age, not a resident of this state, 6.2 or not a citizen of the United States of America. The card must bear: (1) a distinguishing 6.3 number assigned to the applicant; (2) a colored photograph or an electronically produced 6.4 image of the applicant; (3) the applicant's full name and date of birth; (4) either (i) the 6.5 licensee's residence address, or (ii) the designated address under section 5B.05; (5) a 6.6 description of the applicant in the manner as the commissioner deems necessary; (6) the 6.7 usual signature of the applicant; and (7) designations and markings provided under this 6.8 section. 6.9

(b) If the United States Postal Service will not deliver mail to (1) the applicant's residence 6.10 address as listed on the Minnesota identification card, or (2) the applicant's designated 6.11 secondary mailing address, then the applicant shall must provide verification from the United 6.12 States Postal Service that mail will not be delivered to the applicant's residence address or 6.13 designated secondary mailing address and that mail will be delivered to a specified alternate 6.14 mailing address, which must be distinct from a designated secondary mailing address in 6.15 section 171.06, subdivision 3c. When an applicant provides an alternate mailing address 6.16 under this subdivision, the commissioner shall must use the alternate mailing address in 6.17 lieu of the applicant's residence address or designated secondary mailing address for all 6.18 notices and mailings to the applicant. 6.19

- 6.20 (c) Each identification card issued to an applicant under the age of 21 must be of a
 6.21 distinguishing color and plainly marked "Under-21."
- 6.22 (d) Each Minnesota identification card must be plainly marked "Minnesota identification
 6.23 card not a driver's license."
- 6.24 (e) Except for a noncompliant identification card, a Minnesota identification card must
 6.25 bear a distinguishing indicator for compliance with requirements of the REAL ID Act.
- 6.26 (f) A noncompliant identification card must:
- 6.27 (1) be marked "not for federal identification" on the face and in the machine-readable6.28 portion;
- 6.29 (2) have a unique design or color indicator for purposes of the REAL ID Act; and

6.30 (3) bear no indicator or design that relates to the lawful presence or the citizenship of6.31 the identification card holder.

7.1 (g) A REAL ID compliant Minnesota identification card issued to a person with temporary
7.2 lawful status or admission period must be marked "temporary" on the face and in the
7.3 machine-readable portion.

(h) A Minnesota identification card must display the cardholder's full name or no fewer
than 39 characters of the name. Any necessary truncation must begin with the last character
of the middle name and proceed through the second letter of the middle name, followed by
the last character of the first name and proceeding through the second letter of the first name.

(i) The fee for a Minnesota identification card is 50 cents when issued to a person who
is developmentally disabled, as defined in section 252A.02, subdivision 2; a physically
disabled person, as defined in section 169.345, subdivision 2; or, a person with mental
illness, as described in section 245.462, subdivision 20, paragraph (c).

7.12 EFFECTIVE DATE. This section is effective August 1, 2024, and applies to applications 7.13 made on or after that date.

- 7.16 account in the special revenue fund to the commissioner of public safety for costs related
- 7.17 to implementing and administering the designation of a secondary mailing address for
- 7.18 drivers' licenses and identification cards required under Minnesota Statutes, sections 171.06,
- 7.19 subdivision 3c, and 171.07, subdivisions 1 and 3. This is a onetime appropriation and is
- 7.20 available until June 30, 2026.
