1.10	Department of Education shall provide specialized services to people with visual and physical
1.11	disabilities through the Minnesota Braille and Talking Book Library under a cooperative
1.12	plan with the National Library Service for the Blind and Print Disabled of the Library of
1.13	Congress.
1.14	(b) The Department of Education is responsible for bringing awareness of services for
1.15	blind and print disabled persons and is encouraged to develop an online, fully accessible
1.16	website for statewide resources, services, and information available to blind and print
1.17	disabled persons, and assurances to maintain updated documents and publications. The
1.18	Department of Education must consult with the Department of Employment and Economic
1.19	Development regarding vocational rehabilitation services and state services for the blind,
1.20	visually impaired, and deafblind to facilitate the achievement of vocational and personal
1.21	independence, including braille, audio, and e-text and large print transcription services. The
