1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2010, section 290.01, subdivision 19a, is amended to
1.7	read:
1.8	Subd. 19a. Additions to federal taxable income. For individuals, estates, and
1.9	trusts, there shall be added to federal taxable income:
1.10	(1)(i) interest income on obligations of any state other than Minnesota or a political
1.11	or governmental subdivision, municipality, or governmental agency or instrumentality
1.12	of any state other than Minnesota exempt from federal income taxes under the Internal
1.13	Revenue Code or any other federal statute; and
1.14	(ii) exempt-interest dividends as defined in section 852(b)(5) of the Internal Revenue
1.15	Code, except:
1.16	(A) the portion of the exempt-interest dividends exempt from state taxation under
1.17	the laws of the United States; and
1.18	(B) the portion of the exempt-interest dividends derived from interest income
1.19	on obligations of the state of Minnesota or its political or governmental subdivisions,

7.13	Subdivision 1. Definitions. (a) For purposes of this section, the following terms
7.14	have the meanings given.
7.15	(b) "Eligible student" means a student who:
7.16	(1) resides in Minnesota;
7.17	(2) is a member of a household whose total annual income during the year prior
7.18	to initial receipt of a qualified grant, without consideration of the benefits under this
7.19	program, does not exceed an amount equal to 1.5 times the income standard used to
7.20	qualify for a reduced-price meal under the National School Lunch Program, as specified in
7.21	United States Code, title 42, section 1758; and
7.22	(3) either:
7.23	(i) attended a public, nonpublic, or charter school in the semester preceding initial
7.24	receipt of a qualified grant;
7.25	(ii) is starting school in Minnesota for the first time; or

7.28	foundation that makes qualified grants.

7.31	may legally fulfill the state's compulsory attendance laws, that is not operated for profit,
7.32	and that adheres to the provisions of United States Code, title 42, section 1981;
7.33	(2) a charter elementary or secondary school in Minnesota that has at least 30
7.34	percent of its students who qualify for a reduced-price meal under the National School
7.35	Lunch Program; or

8.1	(3) public or nonpublic preschool evaluated to be of high quality and serving
8.2	children ages 3 to 5.
8.3	(e) "Qualified foundation" means a nonprofit organization granted an exemption
8.4	from the federal income tax described in section 501(c)(3) of the Internal Revenue Code
8.5	that complies with the requirements of the equity and opportunity in education tax credit.
8.6	Two or more qualified schools can form a qualified foundation.
8.7	(f) "Qualified grant" means a grant from a qualified foundation for:
8.8	(1) qualified scholarships to a qualified student for tuition to attend a qualified
8.9	school; or
8.10	(2) a qualified charter school for use in support of the school's mission of educating
8.11	eligible students in academics, arts, or athletics, including transportation.
8.12	(g) "Qualified scholarship" means a payment to or on behalf of the parent or guardian
8.13	of a qualified student for payment of tuition at a qualified school. A qualified scholarship
8.14	must not exceed an amount greater than 70 percent of the state average general education
8.15	revenue under section 126C.10, subdivision 1, per pupil unit.
8.16	Subd. 2. Credit allowed. (a) An individual or corporate taxpayer is allowed a
8.17	credit against the tax due under this chapter equal to 80 percent of the amount donated
8.18	to a qualified foundation during the taxable year. No credit is allowed if the taxpayer
8.19	designates a specific child as the beneficiary of the contribution.
8.20	(b) The maximum annual credit allowed is:
8.21	(1) \$20,000 for married joint filers;
8.22	(2) \$10,000 for other individual filers; and
8.23	(3) \$100,000 for corporate filers.
8.24	(c) A taxpayer must provide a copy of the receipt provided by the qualified
8.25	foundation when claiming the credit for the donation.
8.26	(d) The credit is limited to the liability for tax under this chapter, including the tax
8.27	imposed by sections 290.0921 and 290.0922.
8.28	(e) If the amount of the credit under this subdivision for any taxable year exceeds
8.29	the limitations under paragraph (d), the excess is a credit carryover to each of the five

8.32	carried. The amount of the unused credit that may be added under this paragraph may

9.1	Subd. 3. Application for credit certificate. (a) A taxpayer must apply to the
9.2	commissioner for an equity and opportunity in education tax credit certificate.
9.3	(b) The commissioner must not issue a tax credit certificate for an amount greater
9.4	than the limits under subdivision 2.
9.5	Subd. 4. Responsibilities of qualified foundations. (a) Each qualified foundation
9.6	that receives donations directly from taxpayers under this section must:
9.7	(1) notify the commissioner of its intent to participate in this program and, for
9.8	purposes of determining the maximums under subdivision 3, the type of qualified schools
9.9	who receive grants or the type of qualified schools attended by qualified students who
9.10	receive qualified scholarships from that foundation;
9.11	(2) demonstrate to the commissioner that it has been granted an exemption from
9.12	the federal income tax as an organization described in section 501(c)(3) of the Internal
9.13	Revenue Code;
9.14	(3) provide a receipt or verification on a form approved by the commissioner to
9.15	taxpayers for donations and commitments made to qualified foundations;
9.16	(4) conduct criminal background checks on all of its employees and board members
9.17	and exclude from employment or governance any individuals that might reasonably pose a
9.18	risk to the appropriate use of contributed funds;
9.19	(5) demonstrate its financial accountability by:
9.20	(i) submitting a financial information report for the organization that complies with
9.21	uniform financial accounting standards established by the commissioner and conducted by
9.22	a certified public accountant; and
9.23	(ii) having the auditor certify that the report is free of material misstatements;
9.24	(6) demonstrate its financial viability, if they are to receive donations of \$50,000 or
9.25	more during the school year, by filing financial information with the commissioner prior
9.26	to September 1 of each year that demonstrates the financial viability of the qualified
9.27	foundation;
9.28	(7) consistent with paragraph (c), use amounts received as donations to provide
9.29	qualified scholarships or make qualified grants within one calendar year from the
9.30	September 1 following the date of receiving the donation; and
9.31	(8) ensure that a qualified school that receives qualified grants or enrolls eligible
9.32	students:
9.33	(i) complies with all health and safety laws or codes that apply to nonpublic schools;
9.34	(ii) holds a valid occupancy permit if required by its municipality;
9.35	(iii) certifies that it adheres to the provisions of United States Code, title 42, section
9.36	<u>1981; and</u>

10.1	(iv) provides academic accountability to parents of students in the program by
10.2	regularly reporting to the parents on the student's progress.
10.3	(b) A qualified foundation that receives donations directly from taxpayers under this
10.4	program must report to the commissioner by June 1 of each year the following information
10.5	prepared by a certified public accountant regarding its grants in the previous calendar year:
10.6	(1) the total number and total dollar amount of donations from taxpayers received
10.7	during the previous calendar year; and
10.8	(2) the total number and total dollar amount of qualified scholarships or qualified
10.9	grants awarded during the previous calendar year.
10.10	(c) The foundation may use up to seven percent of the amounts received as donations
10.11	for reasonable administrative expenses, including but not limited to fundraising,
10.12	scholarship tracking, and reporting requirements.
10.13	(d) If the commissioner decides to bar a qualified foundation from the program for
10.14	failure to comply with the requirements in paragraph (a), clauses (1) to (8), the qualified
10.15	foundation must notify taxpayers who have donated to the qualified foundation in writing
10.16	within 30 days.
10.17	Subd. 5. Responsibilities of commissioner. (a) The commissioner must prescribe a
10.18	standardized format for a receipt to be issued by a qualified foundation to a taxpayer to
10.19	indicate the value of a donation received.
10.20	(b) The commissioner must prescribe a standardized format for qualified foundations
10.21	to report the information required under subdivision 4.
10.22	(c) The commissioner must post on the department's Web site the names and
10.23	addresses of qualified foundations and regularly update the names and addresses of any
10.24	qualified foundations that have been barred from participating in the program.
10.25	(d) The commissioner may conduct either a financial review or audit of a qualified
10.26	foundation upon finding evidence of fraud or intentional misreporting.
10.27	(e) The commissioner may bar a qualified foundation from participating in the
10.28	program if the commissioner establishes that the qualified foundation has intentionally and
10.29	substantially failed to comply with the requirements in subdivision 4. If the commissioner
10.30	determines that a qualified foundation should be barred from the program, the
10.31	commissioner must notify the qualified foundation within 60 days of that determination.
10.32	<b>EFFECTIVE DATE.</b> This section is effective for taxable years beginning after
10.33	<u>December 31, 2010.</u>
