- 1.9 WHEREAS, on May 13, 2020, by Executive Order 20-53, Governor Walz extended the
- 1.10 peacetime public emergency declared under Executive Order 20-01 and extended in Executive
- 1.11 Order 20-35 until June 12, 2020; and
- 1.12 WHEREAS, on June 12, 2020, by Executive Order 20-75, Governor Walz extended the
- 1.13 peacetime public emergency declared under Executive Order 20-01 and extended in Executive
- 1.14 Orders 20-35 and 20-53; and
- 1.15 WHEREAS, on July 13, 2020, by Executive Order 20-78, Governor Walz extended the
- 1.16 peacetime public emergency declared under Executive Order 20-01 and extended in Executive
- 1.17 Orders 20-35, 20-53, and 20-75; and
- 1.18 WHEREAS, on August 12, 2020, by Executive Order 20-83, Governor Walz extended the
- 1.19 peacetime public emergency declared under Executive Order 20-01 and extended in Executive
- 1.20 Orders 20-35, 20-53, 20-75, and 20-78; and
- 1.21 WHEREAS, on September, 11, 2020, by Executive Order 20-89, Governor Walz extended
- 1.22 the peacetime public emergency declared under Executive Order 20-01 and extended in Executive
- 1.23 Orders 20-35, 20-53, 20-75, 20-78, and 20-83; and

2.1 WHEREAS, in October 2020, by Executive Order Governor Walz extended the peacetime  
2.2 public emergency declared under Executive Order 20-01 and extended in Executive Orders 20-35,  
2.3 20-53, 20-75, 20-78, 20-83, and 20-89; NOW, THEREFORE,

2.4 BE IT RESOLVED by the House of Representatives of the State of Minnesota, the Senate  
2.5 concurring, that the legislature exercises its authority under Minnesota Statutes, section 12.31,  
2.6 subdivision 2, paragraph (b), terminating the peacetime emergency declared under Executive Order  
2.7 20-01.

2.8 BE IT FURTHER RESOLVED that the Chief Clerk of the House of Representatives is  
2.9 directed to prepare an enrolled copy of this resolution, to be authenticated by his signature and  
2.10 those of the Speaker of the House of Representatives, the Chair of the Senate Rules and  
2.11 Administration Committee, and the Secretary of the Senate, and transmit it to it to the Governor of  
2.12 the State of Minnesota.
