1.1 A bill for an act
 1.2 relating to MNsure; requiring the commissioner of commerce to seek federal
 1.3 approval to allow the purchase of qualified health plans and the receipt of
 1.4 premium tax credits and cost-sharing reductions outside of MNsure; imposing a
 1.5 salary limit; specifying approval rates for certain health plans; requiring health
 1.6 carrier notification of enrollment information; providing an option of individual
 1.7 coverage through MNsure; prohibiting certain product lines; requiring a proposal
 1.8 to expand access to the small business health care tax credit; making changes
 1.9 to the organization of MNsure; requiring background checks on navigators
 1.10 operating in MNsure; removing certain exemptions; amending Minnesota
 1.11 Statutes 2014, sections 15A.0815, subdivision 3; 62A.02, subdivision 2; 62V.03,
 1.12 subdivision 2; 62V.04, subdivisions 1, 2, 4; 62V.05, subdivisions 1, 4, 5, 6, by
 1.13 adding subdivisions; 62V.11, subdivision 2, by adding a subdivision; proposing
 1.14 coding for new law in Minnesota Statutes, chapter 62V.

1.15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.16 Section 1. **EXPANDED ACCESS TO QUALIFIED HEALTH PLANS AND**
 1.17 **SUBSIDIES.**

1.18 The commissioner of commerce, in consultation with the board of directors of
 1.19 MNsure and the MNsure legislative oversight committee, shall develop a proposal to
 1.20 allow individuals to purchase qualified health plans outside of MNsure directly from
 1.21 health plan companies and to allow eligible individuals to receive advanced premium tax
 1.22 credits and cost-sharing reductions when purchasing these health plans. The commissioner
 1.23 shall seek all federal waivers and approvals necessary to implement this proposal.
 1.24 The commissioner shall submit a draft proposal to the MNsure board and the MNsure
 1.25 legislative oversight committee at least 30 days before submitting a final proposal to the
 1.26 federal government and shall notify the board and legislative oversight committee of any
 1.27 federal decision or action related to the proposal.

2.1 Sec. 2. Minnesota Statutes 2014, section 15A.0815, subdivision 3, is amended to read:

2.2 Subd. 3. **Group II salary limits.** The salary for a position listed in this subdivision
2.3 shall not exceed 120 percent of the salary of the governor. This limit must be adjusted
2.4 annually on January 1. The new limit must equal the limit for the prior year increased
2.5 by the percentage increase, if any, in the Consumer Price Index for all urban consumers
2.6 from October of the second prior year to October of the immediately prior year. The
2.7 commissioner of management and budget must publish the limit on the department's Web
2.8 site. This subdivision applies to the following positions:

2.9 Executive director of Gambling Control Board;
2.10 Commissioner, Iron Range Resources and Rehabilitation Board;
2.11 Commissioner, Bureau of Mediation Services;
2.12 Ombudsman for Mental Health and Developmental Disabilities;

2.18 Sec. 3. Minnesota Statutes 2014, section 62A.02, subdivision 2, is amended to read:

2.19 Subd. 2. **Approval.** (a) The health plan form shall not be issued, nor shall any
2.20 application, rider, endorsement, or rate be used in connection with it, until the expiration
2.21 of 60 days after it has been filed unless the commissioner approves it before that time.

2.22 (b) Notwithstanding paragraph (a), a rate filed with respect to a policy of accident and
2.23 sickness insurance as defined in section 62A.01 by an insurer licensed under chapter 60A,
2.24 may be used on or after the date of filing with the commissioner. Rates that are not approved
2.25 or disapproved within the 60-day time period are deemed approved. This paragraph does
2.26 not apply to Medicare-related coverage as defined in section 62A.3099, subdivision 17.

2.27 (c) For coverage to begin on or after January 1, 2016, and each January 1 thereafter,
2.28 health plans in the individual and small group markets that are not grandfathered plans to
2.29 be offered outside of MNsure and qualified health plans to be offered inside MNsure must
2.30 receive rate approval from the commissioner no later than 30 days prior to the beginning
2.31 of the annual open enrollment period for MNsure. Premium rates for all carriers in the
2.32 applicable market for the next calendar year must be made available to the public by the
2.33 commissioner only after all rates for the applicable market are final and approved. Final
2.34 and approved rates must be publicly released at a uniform time for all individual and small
2.35 group health plans that are not grandfathered plans to be offered outside MNsure and

3.1 qualified health plans to be offered inside MNsure, and no later than 30 days prior to the
3.2 beginning of the annual open enrollment period for MNsure.

3.3 Sec. 4. Minnesota Statutes 2014, section 62V.03, subdivision 2, is amended to read:

3.4 Subd. 2. **Application of other law.** (a) MNsure must be reviewed by the legislative
3.5 auditor under section 3.971. The legislative auditor shall audit the books, accounts, and
3.6 affairs of MNsure once each year or less frequently as the legislative auditor's funds and
3.7 personnel permit. Upon the audit of the financial accounts and affairs of MNsure, MNsure
3.8 is liable to the state for the total cost and expenses of the audit, including the salaries paid
3.9 to the examiners while actually engaged in making the examination. The legislative
3.10 auditor may bill MNsure either monthly or at the completion of the audit. All collections
3.11 received for the audits must be deposited in the general fund and are appropriated to
3.12 the legislative auditor. Pursuant to section 3.97, subdivision 3a, the Legislative Audit
3.13 Commission is requested to direct the legislative auditor to report by March 1, 2014, to
3.14 the legislature on any duplication of services that occurs within state government as a
3.15 result of the creation of MNsure. The legislative auditor may make recommendations on
3.16 consolidating or eliminating any services deemed duplicative. The board shall reimburse
3.17 the legislative auditor for any costs incurred in the creation of this report.

3.19 members and the personnel of MNsure are subject to section 10A.071.

4.22 Subd. 2. **Appointment.** (a) Board membership of MNsure consists of the following:

5.20 ~~(g)~~ (e) Membership on the board must include representation from outside the
 5.21 seven-county metropolitan area, as defined in section 473.121, subdivision 2.

5.22 Sec. 7. Minnesota Statutes 2014, section 62V.04, subdivision 4, is amended to read:

5.23 Subd. 4. **Conflicts of interest.** (a) Within one year prior to or at any time during
 5.24 their appointed term, board members appointed under subdivision 2, paragraph (a),
 5.25 clauses (1) and (2), shall not be employed by, be a member of the board of directors of, or
 5.26 otherwise be a representative of a health carrier, institutional health care provider or other
 5.27 entity providing health care, navigator, ~~insurance producer~~, or other entity in the business
 5.28 of selling items or services of significant value to or through MNsure. For purposes of this
 5.29 paragraph, "health care provider or entity" does not include an academic institution.

5.30 (b) Board members must recuse themselves from discussion of and voting on
 5.31 an official matter if the board member has a conflict of interest. For board members
 5.32 other than an insurance producer or a county employee, a conflict of interest means an
 5.33 association including a financial or personal association that has the potential to bias or
 5.34 have the appearance of biasing a board member's decisions in matters related to MNsure

6.1 or the conduct of activities under this chapter. The board member who is an insurance
6.2 producer and the board members who are county employees are subject to section 10A.07.

6.3 (c) No board member shall have a spouse who is an executive of a health carrier.

6.4 (d) No member of the board may currently serve as a lobbyist, as defined under
6.5 section 10A.01, subdivision 21.

6.6 Sec. 8. **[62V.045] EXECUTIVE DIRECTOR.**

6.7 The governor shall appoint the executive director of MNsure. The executive director
6.8 serves in the unclassified service at the pleasure of the governor.

6.9 Sec. 9. Minnesota Statutes 2014, section 62V.05, subdivision 1, is amended to read:

6.10 Subdivision 1. **General.** (a) The board shall operate MNsure according to this
6.11 chapter and applicable state and federal law.

6.12 (b) The board has the power to:

6.13 (1) employ personnel, subject to the power of the governor to appoint the executive
6.14 director, and delegate administrative, operational, and other responsibilities to the director
6.15 and other personnel as deemed appropriate by the board. This authority is subject to
6.16 chapters 43A and 179A. The director and managerial staff of MNsure shall serve in the
6.17 unclassified service and shall be governed by a compensation plan prepared by the board,
