1.1 A bill for an act

1.2 relating to education; making certain policy changes for prekindergarten through

1.3 grade 12 education including general education, education excellence, teacher

1.4 licensing, health and safety, special education, and early childhood education;

1.5 authorizing a school district fund transfer; making changes to a report; amending

1.6 Minnesota Statutes 2018, sections 120A.20, by adding a subdivision; 121A.22,

1.7 subdivision 1, by adding a subdivision; 122A.181, subdivision 3; 122A.182,

1.8 subdivision 3; 122A.187, subdivision 6; 123B.52, subdivisions 1, 3; 124D.165,

1.9 subdivisions 3, 4; 125A.08; 125A.30; 125A.50, subdivision 1; 126C.17, subdivision

1.10 9; Minnesota Statutes 2019 Supplement, section 120B.12, subdivision 2; proposing

1.11 coding for new law in Minnesota Statutes, chapters 120B; 121A.

1.12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.13 ARTICLE 1

1.14 GENERAL EDUCATION

1.15 Section 1. Minnesota Statutes 2018, section 123B.52, subdivision 1, is amended to read:

1.16 Subdivision 1. **Contracts.** A contract for work or labor, or for the purchase of furniture,

1.17 fixtures, or other property, except books registered under the copyright laws and information

1.18 systems software, or for the construction or repair of school houses, the estimated cost or

1.19 value of which shall exceed that specified in section 471.345, subdivision 3, must not be

1.20 made by the school board without first advertising for bids or proposals by two weeks'

1.21 published notice in the official newspaper. This notice must state the time and place of

1.22 receiving bids and contain a brief description of the subject matter.

1.23 Additional publication in the official newspaper or elsewhere may be made as the board

1.24 shall deem necessary.

2.1 After taking into consideration conformity with the specifications, terms of delivery,
2.2 and other conditions imposed in the call for bids, every such contract for which a call for
2.3 bids has been issued must be awarded to the lowest responsible bidder, be duly executed
2.4 in writing, and be otherwise conditioned as required by law. The person to whom the contract
2.5 is awarded shall give a sufficient bond to the board for its faithful performance.
2.6 Notwithstanding section 574.26 or any other law to the contrary, on a contract limited to
2.7 the purchase of a finished tangible product, a board may require, at its discretion, a
2.8 performance bond of a contractor in the amount the board considers necessary. A record
2.9 must be kept of all bids, with names of bidders and amount of bids, and with the successful
2.10 bid indicated thereon. A bid containing an alteration or erasure of any price contained in
2.11 the bid which is used in determining the lowest responsible bid must be rejected unless the
2.12 alteration or erasure is corrected as provided in this section. An alteration or erasure may
2.13 be crossed out and the correction thereof printed in ink or typewritten adjacent thereto and
2.14 initialed in ink by the person signing the bid. In the case of identical low bids from two or
2.15 more bidders, the board may, at its discretion, utilize negotiated procurement methods with
2.16 the tied low bidders for that particular transaction, so long as the price paid does not exceed
2.17 the low tied bid price. In the case where only a single bid is received, the board may, at its
2.18 discretion, negotiate a mutually agreeable contract with the bidder so long as the price paid
2.19 does not exceed the original bid. If no satisfactory bid is received, the board may readvertise.
2.20 Standard requirement price contracts established for supplies or services to be purchased
2.21 by the district must be established by competitive bids. Such standard requirement price
2.22 contracts may contain escalation clauses and may provide for a negotiated price increase
2.23 or decrease based upon a demonstrable industrywide or regional increase or decrease in the
2.24 vendor's costs. Either party to the contract may request that the other party demonstrate
2.25 such increase or decrease. The term of such contracts must not exceed two years with an
2.26 option on the part of the district to renew for an additional two years, except as provided in
2.27 subdivision 3 or 7. Contracts for the purchase of perishable food items, except milk for
2.28 school lunches and vocational training programs, in any amount may be made by direct
2.29 negotiation by obtaining two or more written quotations for the purchase or sale, when
2.30 possible, without advertising for bids or otherwise complying with the requirements of this
2.31 section or section 471.345, subdivision 3. All quotations obtained shall be kept on file for
2.32 a period of at least one year after receipt.

2.33 Every contract made without compliance with the provisions of this section shall be
2.34 void. Except in the case of the destruction of buildings or injury thereto, where the public
2.35 interest would suffer by delay, contracts for repairs may be made without advertising for
2.36 bids.

3.1 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.2 Sec. 2. Minnesota Statutes 2018, section 123B.52, subdivision 3, is amended to read:

3.3 Subd. 3. **Transportation; fuel.** Notwithstanding the provisions of subdivision 1 or
3.4 section 471.345, a contract for the transportation of school children, or a contract for the
3.5 purchase of petroleum heating fuel or fuel for vehicles may be made by direct negotiation,
3.6 by obtaining two or more written quotations for the service when possible, or upon sealed
3.7 bids. At least 30 days before awarding a directly negotiated contract, the district must, by
3.8 published notice, request quotations for the service to be provided. All quotations obtained
3.9 must be kept on file for a period of at least one year after receipt. If a contract is made by
3.10 direct negotiation, all quotations must be public information. If a contract is made upon
3.11 sealed bids, the procedure for advertising and awarding bids shall conform to the provisions
3.12 of subdivision 1 except as otherwise provided in this subdivision. The term of such contracts
3.13 must not exceed ten years.

3.14 Notwithstanding the provisions of subdivision 1 or section 574.26, a performance bond
3.15 must be required of a contractor on a contract for the transportation of school children only
3.16 when deemed necessary by and at the discretion of the board. Such a performance bond
3.17 must be in the amount determined by the board.

3.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.19 Sec. 3. Minnesota Statutes 2018, section 126C.17, subdivision 9, is amended to read:

3.20 Subd. 9. **Referendum revenue.** (a) The revenue authorized by section 126C.10,
3.21 subdivision 1, may be increased in the amount approved by the voters of the district at a
3.22 referendum called for the purpose. The referendum may be called by the board. The
3.23 referendum must be conducted one or two calendar years before the increased levy authority,
3.24 if approved, first becomes payable. Only one election to approve an increase may be held
3.25 in a calendar year. Unless the referendum is conducted by mail under subdivision 11,
3.26 paragraph (a), the referendum must be held on the first Tuesday after the first Monday in
3.27 November. The ballot must state the maximum amount of the increased revenue per adjusted
3.28 pupil unit. The ballot may state a schedule, determined by the board, of increased revenue
3.29 per adjusted pupil unit that differs from year to year over the number of years for which the
3.30 increased revenue is authorized or may state that the amount shall increase annually by the
3.31 rate of inflation. For this purpose, the rate of inflation shall be the annual inflationary increase
3.32 calculated under subdivision 2, paragraph (b). The ballot may state that existing referendum
3.33 levy authority is expiring. In this case, the ballot may also compare the proposed levy

4.1 authority to the existing expiring levy authority, and express the proposed increase as the
4.2 amount, if any, over the expiring referendum levy authority. The ballot must designate the
4.3 specific number of years, not to exceed ten, for which the referendum authorization applies.
4.4 The ballot, including a ballot on the question to revoke or reduce the increased revenue
4.5 amount under paragraph (c), must abbreviate the term "per adjusted pupil unit" as "per
4.6 pupil." The notice required under section 275.60 may be modified to read, in cases of
4.7 renewing existing levies at the same amount per pupil as in the previous year:

4.8 "BY VOTING "YES" ON THIS BALLOT QUESTION, YOU ARE VOTING TO
4.9 EXTEND AN EXISTING PROPERTY TAX REFERENDUM THAT IS SCHEDULED
4.10 TO EXPIRE."

4.11 The ballot may contain a textual portion with the information required in this subdivision
4.12 and a question stating substantially the following:

4.13 "Shall the increase in the revenue proposed by (petition to) the board of, School
4.14 District No. ..., be approved?"

4.15 If approved, an amount equal to the approved revenue per adjusted pupil unit times the
4.16 adjusted pupil units for the school year beginning in the year after the levy is certified shall
4.17 be authorized for certification for the number of years approved, if applicable, or until
4.18 revoked or reduced by the voters of the district at a subsequent referendum.

4.19 (b) The board must deliver by mail at least 15 days but no more than ~~30~~ 45 days before
4.20 the day of the referendum to each taxpayer a notice of the referendum and the proposed
4.21 revenue increase. The board need not mail more than one notice to any taxpayer. For the
4.22 purpose of giving mailed notice under this subdivision, owners must be those shown to be
4.23 owners on the records of the county auditor or, in any county where tax statements are
4.24 mailed by the county treasurer, on the records of the county treasurer. Every property owner
4.25 whose name does not appear on the records of the county auditor or the county treasurer is
4.26 deemed to have waived this mailed notice unless the owner has requested in writing that
4.27 the county auditor or county treasurer, as the case may be, include the name on the records
4.28 for this purpose. The notice must project the anticipated amount of tax increase in annual
4.29 dollars for typical residential homesteads, agricultural homesteads, apartments, and
4.30 commercial-industrial property within the school district.

4.31 The notice for a referendum may state that an existing referendum levy is expiring and
4.32 project the anticipated amount of increase over the existing referendum levy in the first
4.33 year, if any, in annual dollars for typical residential homesteads, agricultural homesteads,
4.34 apartments, and commercial-industrial property within the district.

5.1 The notice must include the following statement: "Passage of this referendum will result
5.2 in an increase in your property taxes." However, in cases of renewing existing levies, the
5.3 notice may include the following statement: "Passage of this referendum extends an existing
5.4 operating referendum at the same amount per pupil as in the previous year."

5.5 (c) A referendum on the question of revoking or reducing the increased revenue amount
5.6 authorized pursuant to paragraph (a) may be called by the board. A referendum to revoke
5.7 or reduce the revenue amount must state the amount per adjusted pupil unit by which the
5.8 authority is to be reduced. Revenue authority approved by the voters of the district pursuant
5.9 to paragraph (a) must be available to the school district at least once before it is subject to
5.10 a referendum on its revocation or reduction for subsequent years. Only one revocation or
5.11 reduction referendum may be held to revoke or reduce referendum revenue for any specific
5.12 year and for years thereafter.

5.13 (d) The approval of 50 percent plus one of those voting on the question is required to
5.14 pass a referendum authorized by this subdivision.

5.15 (e) At least 15 days before the day of the referendum, the district must submit a copy of
5.16 the notice required under paragraph (b) to the commissioner and to the county auditor of
5.17 each county in which the district is located. Within 15 days after the results of the referendum
5.18 have been certified by the board, or in the case of a recount, the certification of the results
5.19 of the recount by the canvassing board, the district must notify the commissioner of the
5.20 results of the referendum.

5.21 **EFFECTIVE DATE.** This section is effective July 1, 2020, and applies to referendum
5.22 notices mailed on or after that date.

5.23 **Sec. 4. OGILVIE SCHOOL DISTRICT FUND TRANSFER.**

5.24 (a) Notwithstanding Minnesota Statutes, section 123B.79, 123B.80, or 475.61, subdivision
5.25 4, on June 30, 2021, Independent School District No. 333, Ogilvie, may permanently transfer
5.26 up to \$800,000 from its debt redemption fund to its undesignated general fund balance
5.27 without making a levy reduction. The school board must approve the fund transfer before
5.28 the reporting deadline for fiscal year 2021.

5.29 (b) The transfer in paragraph (a) may be made by the district only after the commissioner
5.30 of education certifies that the transfer does not increase state aid obligations. If the transfer
5.31 increases state aid obligations, the district may pay that amount to the state and transfer any
5.32 remaining balance according to paragraphs (a) and (c).

6.1 (c) Before making any transfers under this section, Independent School District No. 333,
 6.2 Ogilvie, must demonstrate to the commissioner's satisfaction, in response to the
 6.3 commissioner's negative fund balance trend letter or as part of the district's plan to address
 6.4 its statutory operating debt, that the fund transfer will help the district regain an ongoing
 6.5 positive general fund balance.

6.6 **EFFECTIVE DATE.** This section is effective the day following final enactment.

6.7 **ARTICLE 2**

6.8 **EDUCATION EXCELLENCE**

6.9 Section 1. Minnesota Statutes 2019 Supplement, section 120B.12, subdivision 2, is amended
 6.10 to read:

6.11 Subd. 2. **Identification; report.** (a) Each school district must identify before the end of
 6.12 kindergarten, grade 1, and grade 2 all students who are not reading at grade level. Students
 6.13 identified as not reading at grade level by the end of kindergarten, grade 1, and grade 2 must
 6.14 be screened, in a locally determined manner, for characteristics of dyslexia.

6.15 (b) Students in grade 3 or higher who demonstrate a reading difficulty to a classroom
 6.16 teacher must be screened, in a locally determined manner, for characteristics of dyslexia,
 6.17 unless a different reason for the reading difficulty has been identified.

6.18 (c) Reading assessments in English, and in the predominant languages of district students
 6.19 where practicable, must identify and evaluate students' areas of academic need related to
 6.20 literacy. The district also must monitor the progress and provide reading instruction
 6.21 appropriate to the specific needs of English learners. The district must use a locally adopted,
 6.22 developmentally appropriate, and culturally responsive assessment and annually report
 6.23 summary assessment results to the commissioner by July 1.

6.24 (d) The district also must annually report to the commissioner by July 1 a summary of
 6.25 the district's efforts to screen and identify students ~~with:~~

6.26 ~~(1) who demonstrate characteristics of dyslexia; using screening tools such as those~~
 6.27 ~~recommended by the department's dyslexia specialist; or~~

6.28 ~~(2) convergence insufficiency disorder.~~ With respect to students screened or identified
 6.29 under paragraph (a), the report must include:

6.30 (1) a summary of the district's efforts to screen for dyslexia;

6.31 (2) the number of students screened for that reporting year; and

7.1 (3) the number of students demonstrating characteristics of dyslexia for that year.

7.2 (e) A student identified under this subdivision must be provided with alternate instruction
7.3 under section 125A.56, subdivision 1.

7.4 **EFFECTIVE DATE.** This section is effective for the 2020-2021 school year and later.

7.5 Sec. 2. Minnesota Statutes 2018, section 122A.181, subdivision 3, is amended to read:

7.6 Subd. 3. **Term of license and renewal.** (a) The Professional Educator Licensing and
7.7 Standards Board must issue an initial Tier 1 license for a term of one year. A Tier 1 license
7.8 may be renewed subject to paragraphs (b) and (c). The board may submit written comments
7.9 to the district or charter school that requested the renewal regarding the candidate.

7.10 (b) The Professional Educator Licensing and Standards Board must renew a Tier 1
7.11 license if:

7.12 (1) the district or charter school requesting the renewal demonstrates that it has posted
7.13 the teacher position but was unable to hire an acceptable teacher with a Tier 2, 3, or 4 license
7.14 for the position;

7.15 (2) the teacher holding the Tier 1 license took a content examination in accordance with
7.16 section 122A.185 and submitted the examination results to the teacher's employing district
7.17 or charter school within one year of the board approving the request for the initial Tier 1
7.18 license; ~~and~~

7.19 (3) the teacher holding the Tier 1 license participated in cultural competency training
7.20 consistent with section 120B.30, subdivision 1, paragraph (q), within one year of the board
7.21 approving the request for the initial Tier 1 license; and

7.22 (4) the teacher holding the Tier 1 license met the mental illness training renewal
7.23 requirement under section 122A.187, subdivision 6.

7.24 The requirement in clause (2) does not apply to a teacher that teaches a class in a career and
7.25 technical education or career pathways course of study.

7.26 (c) A Tier 1 license must not be renewed more than three times, unless the requesting
7.27 district or charter school can show good cause for additional renewals. A Tier 1 license
7.28 issued to teach (1) a class or course in a career and technical education or career pathway
7.29 course of study or (2) in a shortage area, as defined in section 122A.06, subdivision 6, may
7.30 be renewed without limitation.

7.31 **EFFECTIVE DATE.** This section is effective for licenses issued on or after July 1,
7.32 2021.

8.1 Sec. 3. Minnesota Statutes 2018, section 122A.182, subdivision 3, is amended to read:

8.2 Subd. 3. **Term of license and renewal.** The Professional Educator Licensing and
8.3 Standards Board must issue an initial Tier 2 license for a term of two years. A Tier 2 license
8.4 may be renewed three times. Before a Tier 2 license is renewed for the first time, a teacher
8.5 holding a Tier 2 license must participate in cultural competency training consistent with
8.6 section 120B.30, subdivision 1, paragraph (q), and mental illness training under section
8.7 122A.187, subdivision 6. The board must issue rules setting forth the conditions for additional
8.8 renewals after the initial license has been renewed three times.

8.9 **EFFECTIVE DATE.** This section is effective for licenses issued on or after July 1,
8.10 2021.

8.11 Sec. 4. Minnesota Statutes 2018, section 122A.187, subdivision 6, is amended to read:

8.12 Subd. 6. **Mental illness.** The Professional Educator Licensing and Standards Board must
8.13 adopt rules that require all licensed teachers renewing a ~~Tier 3 or Tier 4~~ teaching license
8.14 under sections ~~122A.183 and~~ 122A.181 to 122A.184, respectively, to include in the renewal
8.15 requirements at least one hour of suicide prevention best practices training in each licensure
8.16 renewal period based on nationally recognized evidence-based programs and practices,
8.17 among the continuing education credits required to renew a license under this subdivision;
8.18 ~~and further preparation, first, in.~~ Initial training must include understanding the key warning
8.19 signs of early-onset mental illness in children and adolescents, ~~and then,~~ during subsequent
8.20 licensure renewal periods, ~~preparation may~~ training must include providing a more in-depth
8.21 understanding of students' mental illness trauma, accommodations for students' mental

8.28 Section 1. **[120B.238] VAPING AWARENESS AND PREVENTION.**

8.29 Subdivision 1. **Title.** This section may be referred to as the "Vaping Awareness and
8.30 Prevention Act."

8.31 Subd. 2. **Definitions.** (a) For purposes of this section, the words defined in this
8.32 subdivision have the meanings given them.

9.1 (b) "Electronic delivery device" has the meaning given in section 609.685, subdivision
9.2 1.

9.3 (c) "Heated tobacco product" means a tobacco product that produces aerosols containing
9.4 nicotine and other chemicals which are inhaled by users through the mouth.

9.5 (d) "Public school" means a school district or a charter school.

9.6 (e) "Vaping" means using an activated electronic delivery device or heated tobacco
9.7 product.

9.8 Subd. 3. **School instruction requirements.** (a) A public school must provide vaping
9.9 prevention instruction at least once to students in grades 6 through 8. A public school may
9.10 use instructional materials based on the Department of Health's e-cigarette toolkit or may
9.11 use other smoking prevention instructional materials with a focus on vaping and the use of
9.12 electronic delivery devices and heated tobacco products. The instruction may be provided
9.13 as a part of a public school's locally developed health standards.

9.14 (b) A public school is strongly encouraged to provide evidence-based vaping prevention
9.15 instruction to students in grades 9 through 12.

9.16 (c) A public school is encouraged to use a peer-to-peer education program to provide
9.17 vaping prevention instruction.

9.18 Subd. 4. **Student survey.** The commissioner of education must include questions
9.19 regarding tobacco use and vaping in the Minnesota student survey.

9.20 **EFFECTIVE DATE.** This section is effective for the 2021-2022 school year and later.

9.21 Sec. 2. Minnesota Statutes 2018, section 121A.22, subdivision 1, is amended to read:

9.22 Subdivision 1. **Applicability.** (a) This section applies only:

9.23 (1) when the parent of a pupil requests school personnel to administer drugs or medicine
9.24 to the pupil; or

9.25 (2) when administration is allowed by the individualized education program of a child
9.26 with a disability.

9.27 The request of a parent may be oral or in writing. An oral request must be reduced to
9.28 writing within two school days, provided that the district may rely on an oral request until
9.29 a written request is received.

9.30 (b) If the administration of a drug or medication described in paragraph (a) requires a
9.31 school to store the drug or medication, the parent or legal guardian must inform the school

10.1 if the drug or medication is a controlled substance. For a drug or medication that is not a
10.2 controlled substance, the request must include a provision designating the school district
10.3 as an authorized entity to transport the drug or medication for the purpose of destruction if
10.4 any unused drug or medication remains in the possession of school personnel. For a drug
10.5 or medication that is a controlled substance, the request must specify that the parent or legal
10.6 guardian is required to retrieve the drug or controlled substance when requested by the
10.7 school.

10.8 Sec. 3. Minnesota Statutes 2018, section 121A.22, is amended by adding a subdivision to
10.9 read:

10.10 Subd. 4a. **Unclaimed drugs or medications.** (a) Each school district must adopt a
10.11 procedure for the collection and transport of any unclaimed or abandoned prescription drugs
10.12 or medications remaining in the possession of school personnel in accordance with this
10.13 subdivision. The procedure must ensure that before the transportation of any prescription
10.14 drug or medication under this subdivision, the school district shall make a reasonable attempt
10.15 to return the unused prescription drug or medication to the student's parent or legal guardian.
10.16 The procedure must provide that transportation of unclaimed or unused prescription drugs
10.17 or medications occur at least annually, or more frequently as determined by the school
10.18 district.

10.19 (b) If the unclaimed or abandoned prescription drug is not a controlled substance as
10.20 defined under section 152.01, subdivision 4, or is an over-the-counter medication, the school
10.21 district may designate an individual who shall be responsible for transporting the drug or
10.22 medication to a designated drop-off box or collection site or may request that a law
10.23 enforcement agency transport the drug or medication to a drop-off box or collection site on
10.24 behalf of the school district.

10.25 (c) If the unclaimed or abandoned prescription drug is a controlled substance as defined
10.26 in section 152.01, subdivision 4, a school district or school personnel is prohibited from
10.27 transporting the prescription drug to a drop-off box or collection site for prescription drugs
10.28 identified under this paragraph. The school district must request that a law enforcement
10.29 agency transport the prescription drug or medication to a collection bin that complies with
10.30 Drug Enforcement Agency regulations, or if a site is not available, under the agency's
10.31 procedure for transporting drugs.

(1) all students with disabilities are provided the special instruction and services which are appropriate to their needs. Where the individualized education program team has determined appropriate goals and objectives based on the student's needs, including the extent to which the student can be included in the least restrictive environment, and where there are essentially equivalent and effective instruction, related services, or assistive technology devices available to meet the student's needs, cost to the district may be among the factors considered by the team in choosing how to provide the appropriate services, instruction, or devices that are to be made part of the student's individualized education program. The individualized education program team shall consider and may authorize services covered by medical assistance according to section 256B.0625, subdivision 26. Before a school district evaluation team makes a determination of other health disability under Minnesota Rules, part 3525.1335, subparts 1 and 2, item A, subitem (1), the evaluation team must seek written documentation of the student's medically diagnosed chronic or acute health condition signed by a licensed physician or a licensed health care provider acting within the scope of the provider's practice. The student's needs and the special education instruction and services to be provided must be agreed upon through the development of an individualized education program. The program must address the student's need to develop skills to live and work as independently as possible within the community. The individualized education program team must consider positive behavioral interventions, strategies, and supports that address behavior needs for children. During grade 9, the program must address the student's needs for transition from secondary services to postsecondary education and training, employment, community participation, recreation, and leisure and home living. In developing the program, districts must inform parents of the full range of transitional goals and related services that should be considered. The program must include a statement of the needed transition services, including a statement of the interagency responsibilities or linkages or both before secondary services are concluded. If the individualized education

12.1 program meets the plan components in section 120B.125, the individualized education
12.2 program satisfies the requirement and no additional transition plan is needed;

12.3 (2) children with a disability under age five and their families are provided special
