## A bill for an act

2.26	REGULATION OF ADULT-USE CANNABIS
2.27	Section 1. [342.01] DEFINITIONS.
2.28	Subdivision 1. Terms. For the purposes of this chapter, the following terms have the
2.29	meanings given them.
2.30	Subd. 2. Adult-use cannabis concentrate. "Adult-use cannabis concentrate" means
2.31	cannabis concentrate that is approved for sale by the office or is substantially similar to a
2.32	product approved by the office. Adult-use cannabis concentrate does not include any
2.33	artificially derived cannabinoid.
2.34	Subd. 3. Adult-use cannabis flower. "Adult-use cannabis flower" means cannabis
2.35	flower that is approved for sale by the office or is substantially similar to a product approved
2.36	by the office. Adult-use cannabis flower does not include medical cannabis flower, hemp
2.37	plant parts, or hemp-derived consumer products.

Subd. 4. Adult-use cannabis product. "Adult-use cannabis product" means a cannabis

3.2	product that is approved for sale by the office or is substantially similar to a product approved
3.3	by the office. Adult-use cannabis product includes edible cannabis products but does not
3.4	include medical cannabinoid products or lower-potency hemp edibles.
3.5	Subd. 5. Advertisement. "Advertisement" means any written or oral statement,
3.6	illustration, or depiction that is intended to promote sales of cannabis flower, cannabis
3.7	products, lower-potency hemp edibles, hemp-derived consumer products, or sales at a
3.8	specific cannabis business or hemp business and includes any newspaper, radio, internet
3.9	and electronic media, or television promotion; the distribution of fliers and circulars; and
3.10	the display of window and interior signs in a cannabis business. Advertisement does not
3.11	include a fixed outdoor sign that meets the requirements in section 342.64, subdivision 2,
3.12	paragraph (b).
3.13	Subd. 6. Artificially derived cannabinoid. "Artificially derived cannabinoid" means a
3.14	cannabinoid extracted from a cannabis plant, cannabis flower, hemp plant, or hemp plant
3.15	parts with a chemical makeup that is changed after extraction to create a different cannabinoid
3.16	or other chemical compound by applying a catalyst other than heat or light. Artificially
3.17	derived cannabinoid includes but is not limited to any tetrahydrocannabinol created from
3.18	cannabidiol but does not include cannabis concentrate, cannabis products, hemp concentrate,
3.19	lower-potency hemp edibles, or hemp-derived consumer products.
3.20	Subd. 7. Batch. "Batch" means:
3.21	(1) a specific quantity of cannabis plants that are cultivated from the same seed or plant
3.22	stock, are cultivated together, are intended to be harvested together, and receive an identical
3.23	propagation and cultivation treatment;
3.24	(2) a specific quantity of cannabis flower that is harvested together; is uniform and
3.25	intended to meet specifications for identity, strength, purity, and composition; and receives
3.26	identical sorting, drying, curing, and storage treatment; or
3.27	(3) a specific quantity of a specific cannabis product, lower-potency hemp edible,
3.28	artificially derived cannabinoid, hemp-derived consumer product, or hemp-derived topical
3.29	product that is manufactured at the same time and using the same methods, equipment, and
3.30	ingredients that is uniform and intended to meet specifications for identity, strength, purity,
3.31	and composition, and that is manufactured, packaged, and labeled according to a single
3.32	batch production record executed and documented.
3.33	Subd. 8. Batch number. "Batch number" means a unique numeric or alphanumeric
3.34	identifier assigned to a batch of cannabis plants, cannabis flower, cannabis products.

4.12	the process of extracting concentrate from hemp plants or hemp plant parts or the process
4.13	of creating any artificially derived cannabinoid.
4.14	Subd. 12. Cannabinoid product. "Cannabinoid product" means a cannabis product, a
4.15	hemp-derived consumer product, or a lower-potency hemp edible.
4.16	Subd. 13. Cannabinoid profile. "Cannabinoid profile" means the amounts of each
4.17	cannabinoid that the office requires to be identified in testing and labeling, including but
4.18	not limited to delta-9 tetrahydrocannabinol, tetrahydrocannabinolic acid, cannabidiol, and
4.19	cannabidiolic acid in cannabis flower, a cannabis product, a batch of artificially derived
4.20	cannabinoid, a lower-potency hemp edible, a hemp-derived consumer product, or a
4.21	hemp-derived topical product expressed as percentages measured by weight and, in the case
4.22	of cannabis products, lower-potency hemp edibles, and hemp-derived consumer products,
4.23	expressed as milligrams in each serving and package.
4.24	Subd. 14. Cannabis business. "Cannabis business" means any of the following licensed
4.25	under this chapter:

5.15	(b) Cannabis concentrate does not include hemp concentrate, artificially derived

5.17	Subd. 16. Cannabis flower. "Cannabis flower" means the harvested flower, bud, leaves
5.18	and stems of a cannabis plant. Cannabis flower includes adult-use cannabis flower and
5.19	medical cannabis flower. Cannabis flower does not include cannabis seed, hemp plant parts
5.20	or hemp-derived consumer products.
5.21	Subd. 17. Cannabis industry. "Cannabis industry" means every item, product, person
5.22	process, action, business, or other thing related to cannabis flower and cannabis products
5.23	and subject to regulation under this chapter.
5.24	Subd. 18. Cannabis paraphernalia. "Cannabis paraphernalia" means all equipment,
5.25	products, and materials of any kind that are knowingly or intentionally used primarily in:
5.26	(1) manufacturing cannabis products;
5.27	(2) ingesting, inhaling, or otherwise introducing cannabis flower or cannabis products
5.28	into the human body; and
5.29	(3) testing the strength, effectiveness, or purity of cannabis flower, cannabis products,

6.17	all agronomical varieties, whether growing or not; the seeds thereof; the resin extracted
6.18	from any part of such plant; and every compound, manufacture, salt, derivative, mixture,
6.19	or preparation of such plant, its seeds, or resin.
6.20	Subd. 22. Cannabis seed. "Cannabis seed" means the viable seed of the plant of the
6.21	genus Cannabis that is reasonably expected to grow into a cannabis plant. Cannabis seed

(1) consists of or contains cannabis concentrate or hemp concentrate or is infused with

  - (d) This prohibition does not apply to free samples of cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products provided to a retailer or cannabis wholesaler for the purposes of quality control and to allow retailers to determine whether to offer a product for sale. If information regarding the industrial hemp or hemp-derived consumer product was submitted to a statewide monitoring system used in another state, the office may require submission of any information provided to that statewide monitoring system and shall assist in the transfer of data from another state as needed and in compliance with any data classification established by either state.

This education program must also educate individuals on what constitutes a substance use disorder, signs of a substance use disorder, and treatment options for persons with a substance use disorder.
