memorializing the United States government to honor veterans by funding construction 1.2 costs for proposed veterans homes in Bemidji, Montevideo, and Preston. 1.3 WHEREAS, the State of Minnesota honors all veterans who have bravely served in the United 1.4 States armed forces; and 1.5 WHEREAS, the State of Minnesota wishes to show gratitude to those valorous individuals 1.6 by increasing access to high-quality medical care for our veterans and their spouses through the 1.7 construction of veterans homes in the communities of Bemidji, Montevideo, and Preston; and 1.8 WHEREAS, the communities of Bemidji, Montevideo, and Preston have shown strong and 19 1.10 continual support for the construction of a veterans home in their communities; and WHEREAS, funding from the State of Minnesota to predesign, design, construct, furnish, 1.11 and equip veterans homes in those communities has been enacted into state law; and 1.12 WHEREAS, the law that provides this funding also commits the State of Minnesota to 1 13 "provide the necessary operating costs for the veterans homes in excess of any revenue and federal 1.14 funding for the homes that may be required to continue the operation of the homes and care for 1.15 Minnesota veterans;" and 1.16 WHEREAS, the United States government has historically provided a share of the funding 1.17 to construct veterans homes; and 1.18 WHEREAS, financial support from the United States government is crucial to ensure that 1.19 1.20 these veterans homes are completed; NOW, THEREFORE, BE IT RESOLVED by the Legislature of the State of Minnesota that it urges the Congress 1.21 of the United States and the United States Department of Veterans Affairs to allocate all necessary 1.22
