1.7	Section 1. Minnesota Statutes 2012, section 462A.37, subdivision 2, is amended to read:
1.8	Subd. 2. Authorization. (a) The agency may issue up to \$30,000,000 in aggregate
1.9	principal amount of housing infrastructure bonds in one or more series to which the
1.10	payment made under this section may be pledged.
1.11	(b) The agency may issue up to \$35,000,000 in aggregate principal amount of
1.12	housing infrastructure bonds in one or more series to which the payment made under this
1.13	section may be pledged.
1.14	(c) The housing infrastructure bonds authorized in this subdivision may be issued
1.15	to fund loans, on terms and conditions the agency deems appropriate, made for one or
1.16	more of the following purposes:
1.17	(1) to finance the costs of the construction, acquisition, and rehabilitation of
1.18	supportive housing for individuals and families who are without a permanent residence;
1.19	(2) to finance the costs of the acquisition and rehabilitation of foreclosed or

 finance or refinance such costs.

- 2.32 Subdivision 1. Appropriation. \$15,000,000 is appropriated from the bond proceeds
- 2.33 <u>fund to the Housing Finance Agency for transfer to the housing development fund to</u>
- 2.34 finance the costs of rehabilitation to preserve public housing under Minnesota Statutes,

section 462A.202, subdivision 3a. For purposes of this section, "public housing" means 3.1 3.2 housing for low-income persons and households financed by the federal government and owned and operated by the public housing authorities and agencies formed by cities and 3.3 counties. Public housing authorities receiving a public housing assessment composite 3.4 score of 80 or above are eligible to receive funding. Priority must be given to proposals 3.5 that maximize federal or local resources to finance the capital costs. The priority in 3.6 Minnesota Statutes, section 462A.202, subdivision 3a, for projects to increase the supply 3.7 of affordable housing and the restrictions of Minnesota Statutes, section 462A.202, 3.8 subdivision 7, do not apply to this appropriation. 3.9 Subd. 2.
