- 8.9 excess of 40 hours per seven-day period regardless of the number of parents providing
- 8.10 services, combination of parents and spouses providing services, or number of children who
- 8.11 receive medical assistance services; and
- 8.12 (9) worker training and development services as described in subdivision 18a.
- 8.13 **EFFECTIVE DATE.** This section is effective upon federal approval. The service will
- 8.14 begin 90 days after federal approval. The commissioner of human services shall notify the
- 8.15 revisor of statutes when federal approval is obtained.
