1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2020, section 171.13, subdivision 1, is amended to read:
1.7	Subdivision 1. Examination subjects and locations; provisions for color blindness,
1.8	disabled veterans. (a) Except as otherwise provided in this section, the commissioner shall
1.9	examine each applicant for a driver's license by such agency as the commissioner directs.
1.10	This examination must include:
1.11	(1) a test of the applicant's eyesight;
1.12	(2) a test of the applicant's ability to read and understand highway signs regulating,
1.13	warning, and directing traffic;
1.14	(3) a test of the applicant's knowledge of (i) traffic laws; (ii) the effects of alcohol and
1.15	drugs on a driver's ability to operate a motor vehicle safely and legally, and of the legal
1.16	penalties and financial consequences resulting from violations of laws prohibiting the
1.17	operation of a motor vehicle while under the influence of alcohol or drugs; (iii) railroad
1.18	grade crossing safety; (iv) slow-moving vehicle safety; (v) laws relating to pupil
1.19	transportation safety, including the significance of school bus lights, signals, stop arm, and
