1.13 **DEPARTMENT OF REVENUE INDIVIDUAL INCOME, CORPORATE**

1.14 **FRANCHISE, AND ESTATE TAX TECHNICAL PROVISIONS**

1.15 Section 1. Minnesota Statutes 2016, section 290.0132, subdivision 21, is amended to read:

1.16 Subd. 21. **Military service pension; retirement pay.** To the extent included in federal

1.17 taxable income, compensation received from a pension or other retirement pay from the

1.18 federal government for service in the military, as computed under United States Code, title

1.19 10, sections 1401 to 1414, 1447 to 1455, and 12733, is a subtraction. The subtraction ~~must~~

1.20 ~~not include any amount used to claim the credit allowed under section 290.0677~~ is limited

1.21 to individuals who do not claim the credit under section 290.0677.

1.22 **EFFECTIVE DATE.** This section is effective retroactively for taxable years beginning

1.23 after December 31, 2015.

2.2 Subd. 3. **Income.** (a) "Income" means the sum of the following:

2.3 (1) federal adjusted gross income as defined in the Internal Revenue Code; and

2.5 (i) all nontaxable income;

2.6 (ii) the amount of a passive activity loss that is not disallowed as a result of section 469,  
2.7 paragraph (i) or (m) of the Internal Revenue Code and the amount of passive activity loss  
2.8 carryover allowed under section 469(b) of the Internal Revenue Code;

2.9 (iii) an amount equal to the total of any discharge of qualified farm indebtedness of a  
2.10 solvent individual excluded from gross income under section 108(g) of the Internal Revenue  
2.11 Code;

2.12 (iv) cash public assistance and relief;

2.13 (v) any pension or annuity (including railroad retirement benefits, all payments received  
2.14 under the federal Social Security Act, Supplemental Security Income, and veterans benefits),

3.11 (xvii) the amount deducted for certain expenses of elementary and secondary school  
3.12 teachers under section 62(a)(2)(D) of the Internal Revenue Code.

3.13 In the case of an individual who files an income tax return on a fiscal year basis, the  
3.14 term "federal adjusted gross income" shall mean federal adjusted gross income reflected in  
3.15 the fiscal year ending in the calendar year. Federal adjusted gross income shall not be reduced  
3.16 by the amount of a net operating loss carryback or carryforward or a capital loss carryback  
3.17 or carryforward allowed for the year.

3.18 (b) "Income" does not include:

3.19 (1) amounts excluded pursuant to the Internal Revenue Code, sections 101(a) and 102;

3.20 (2) amounts of any pension or annuity which was exclusively funded by the claimant  
3.21 or spouse and which funding payments were not excluded from federal adjusted gross  
3.22 income in the years when the payments were made;

3.23 (3) to the extent included in federal adjusted gross income, amounts contributed by the  
3.24 claimant or spouse to a traditional or Roth style retirement account or plan, but not to exceed  
3.25 the retirement base amount reduced by the amount of contributions excluded from federal  
3.26 adjusted gross income, but not less than zero;

3.27 (4) surplus food or other relief in kind supplied by a governmental agency;

3.29 (6) child support payments received under a temporary or final decree of dissolution or

4.26 or a reproduction thereof in a form deemed satisfactory by the commissioner of revenue  
4.27 indicating that there are no delinquent property taxes on the homestead. Indication on the  
4.28 property tax statement from the county treasurer that there are no delinquent taxes on the  
4.29 homestead shall be sufficient proof. Taxes included in a confession of judgment under  
4.30 section 277.23 or 279.37 shall not constitute delinquent taxes as long as the claimant is

5.19 Section 1. Minnesota Statutes 2016, section 270.078, subdivision 1, is amended to read:

5.20 Subdivision 1. **Conformance to federal law.** If any provision of sections 270.071 to  
5.21 270.079 is contrary to any provision of any law of the United States of America, hereinafter  
5.22 enacted, providing for or relating to the ad valorem taxation by a state of aircraft or flying  
5.23 equipment of an airline company, such provision shall be of no effect and the commissioner  
5.24 is authorized and directed to prescribe by rule such provisions as may be necessary to make  
5.25 sections 270.071 to 270.079 conform to the federal act and to effectuate the purposes of  
5.26 sections 270.071 to 270.079, provided such rules do not prescribe a rate of taxation higher  
5.27 than that provided in section 270.075 or a net tax capacity based on a percentage higher  
5.28 than that provided in section 270.074, subdivision ~~2~~ 3.

6.2 **273.0755 TRAINING AND EDUCATION OF PROPERTY TAX PERSONNEL.**

6.3 (a) Beginning with the four-year period starting on July 1, 2000, every person licensed  
6.4 by the state Board of Assessors at the Accredited Minnesota Assessor level or higher, shall  
6.5 successfully complete a weeklong Minnesota laws course sponsored by the Department of  
6.6 Revenue at least once in every four-year period. An assessor need not attend the course if  
6.7 they successfully pass the test for the course.

6.8 (b) The commissioner of revenue may require that each county, and each city for which  
6.9 the city assessor performs the duties of county assessor, have (i) a person on the assessor's  
6.10 staff who is certified by the Department of Revenue in sales ratio calculations, (ii) an officer  
6.11 or employee who is certified by the Department of Revenue in tax calculations, and (iii) an  
6.12 officer or employee who is certified by the Department of Revenue in the proper preparation

6.21 requirement must be met at least once in every subsequent four-year period. This requirement  
6.22 applies to all assessors licensed for one year or more in the four-year period.

9.14 Department of Revenue either has agreed to or is required to administer the tax, such that  
9.15 the tax is reported and paid with the chapter 297A taxes, then ~~the local government unit or~~  
9.16 ~~group of units must adopt~~ each ~~definition term~~ used in the special law is defined as follows:

9.17 (1) ~~the definition must be identical to the definition found~~ as defined in chapter 297A  
9.18 or in Minnesota Rules, chapter 8130; or
